

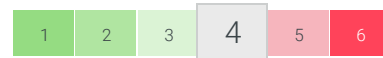

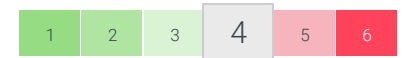

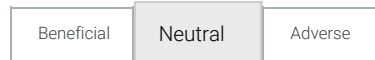

### Sales Comparison Analysis

#### DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. Comps 2 - 4 were adjusted for their location on a less traveled road. Comps 1 and 3 are less than 100sf different in GLA therefore, no adjustment is warranted. An additional GLA adjustment was given for comp 2 as the total was too larger for the GLA box. Per online photos comps 1, 2, and 4 appear to be superior in condition and quality. Comp 3 is similar in condition. Most weight is given to comp 1 for its proximity.

#### EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

#### ADDITIONAL COMMENTS (OPTIONAL)

### Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$1,100,000 +/- appears to be considered reasonable as of 2/19/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.
