Values have been adjusted as appropriate based on differences in condition, location, amenities or other significant features. The value conclusion is based on a calculated weighting of both the sold and active listings with greatest weight placed on those listings closest in condition and square footage. The sold comparable listings moved off the market above what is typical for this area which led to the final pricing for the subject to be set less aggressively to encourage the desired marketing period for a fair market value as requested in this report.</p>

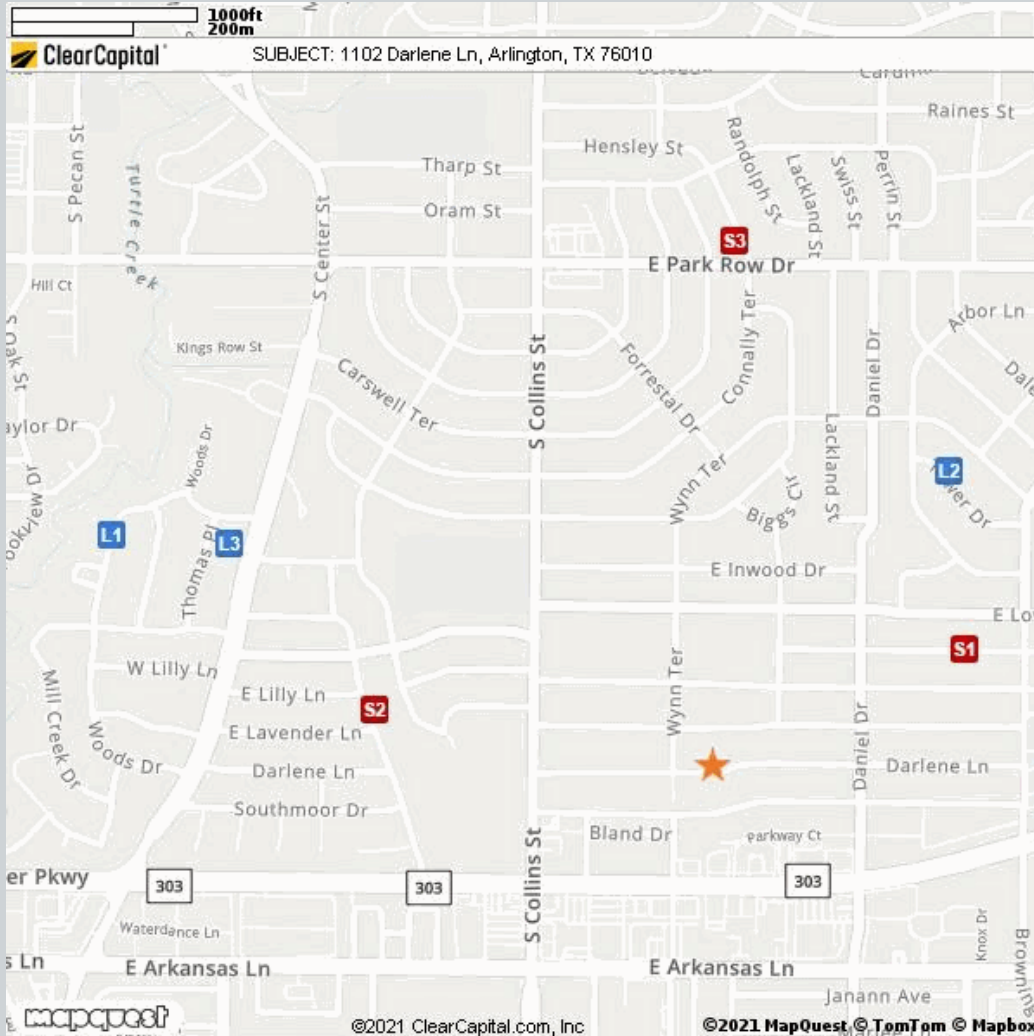
