### Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. All comps except 2 are less than 100sf different in GLA therefore, no adjustment is warranted. Per online photos comp 1 is inferior in condition and quality. Comp 2 appears to be similar in condition and quality. Comp 3 is superior in condition/quality while comp 4 is slightly superior in condition and quality. Most weight is given to comp 2 for its similarity.

**EXPLANATION OF ADJUSTMENTS** 

Amenity differences have been adjusted properly and are deemed customary for the area. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

### Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$890k +/-appears to be considered reasonable as of 2/22/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.






