- Sold 2** Comparable sale 2 is slightly smaller than the subject with 1/2 more bathrooms. Negative adjustments for 1/2 bathroom \$5,000 with a positive adjustment for GLA \$17,200.

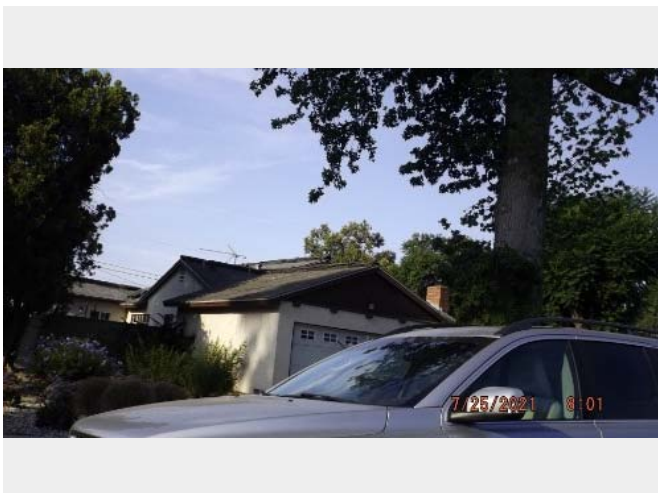

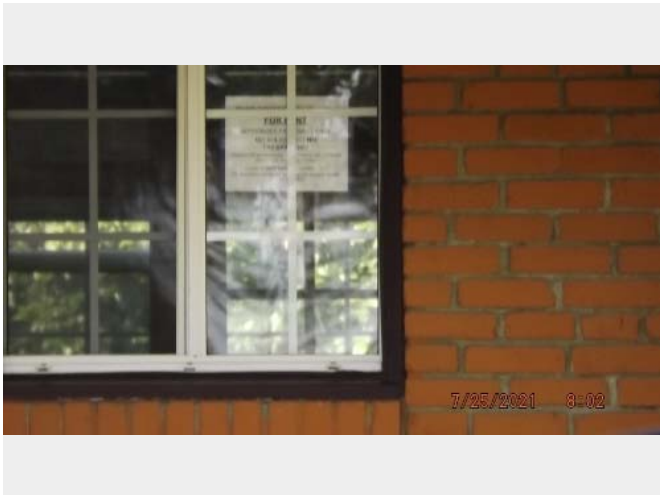

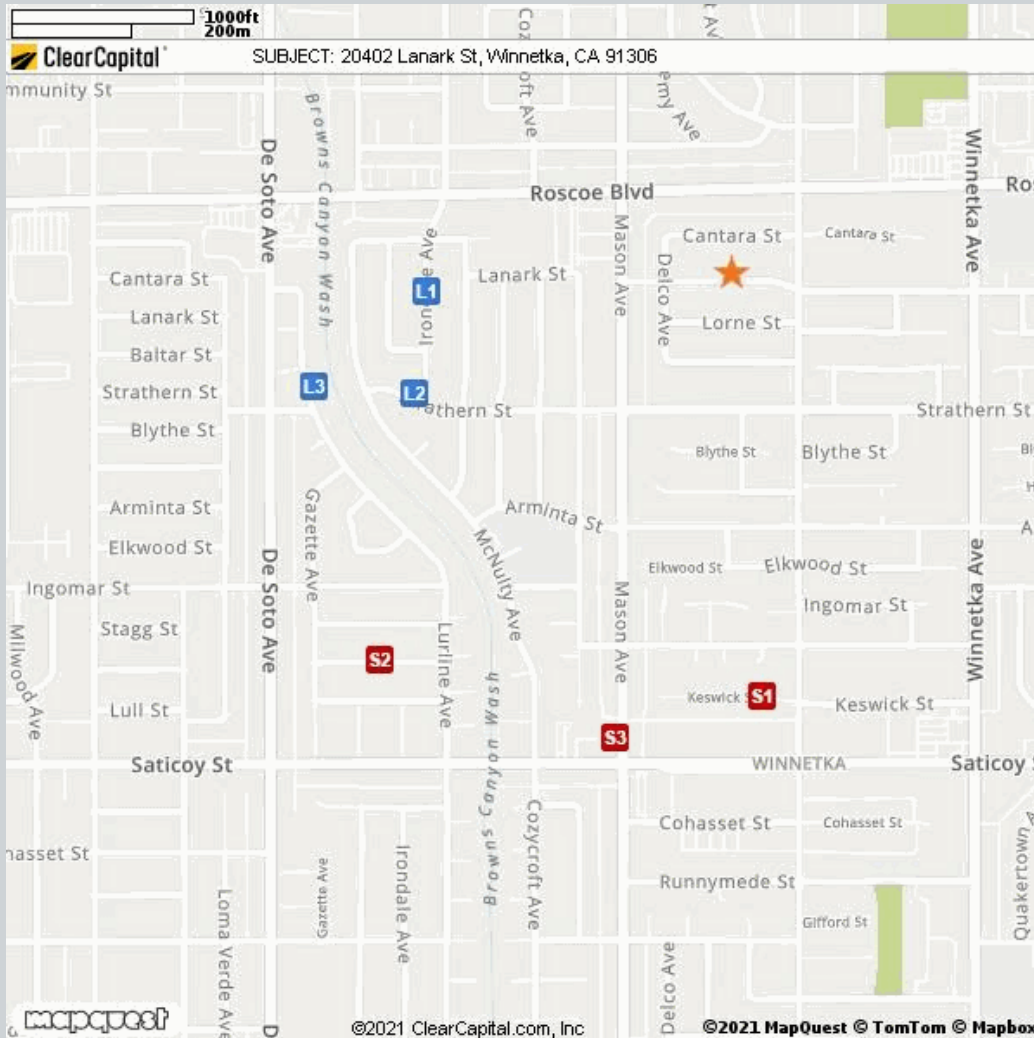
