

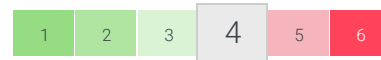

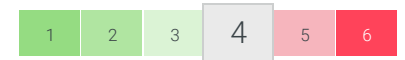

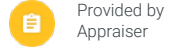

Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

A one mile radius search of detached homes was used.

EXPLANATION OF ADJUSTMENTS

The comps selected are from the subject's overall market area. Comps were adjusted for differences in GLA, bath count, garage and pool or amenities. No bedroom count adjustment was made as a supportable adjustment could not be extracted from available market data. Comps 1,2 were adjusted downward for superior usable lot area and comps 3,4 deemed to have similar usable lot area.


ADDITIONAL COMMENTS (OPTIONAL)

Some of the comps exceeded typical lender guidelines (10/15/25%) but were included due to proximity and bracketing of items in the SCA grid. Comps 3,4 had dates of sale older than 6 months but were included to bracket the subject's lot area.

Reconciliation Summary

Most weight given to comp 1 as it was deemed the most reliable indicator of value.

The purpose of this Appraisal Report is to determine an and the opinion of the market value for the subject property, at which it could sell in a typical exposure time for the area, considering current market conditions, the condition of the subject and necessary repairs.

SCOPE OF WORK:

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Michelle Thompson, a licensed real estate agent having completed the above referenced Property Inspection.
