#### **Comments Regarding Pricing Strategy**

Subject property transfered as a foreclosure (REO) on 2/24/2021 for 544,500 this sale is not indicative of current market value as it is not a fair market sale. Additionally based off of MLS subject has been remodeled and updated recently. I have provided sale 3 to bracket GLA, adjusted this comp for condition as it is not updated in a similar condition that subject has been confirmed to be per the attached MLS. Subject is listed at the higher end of the market and value is not supported by comparables, comps used some of which are larger in size, support a lower value, the higher list price varies from my market value as it appears the property was listed above market value. Property value of the subject was assessed based upon the values of comparable properties in the area, as well as their condition, and comparison to the subject. Subject's lot size varies over 10% of comparables, the age difference in some comparables are over 5 years and distance of some comparables are over 1 mile from subject in terms of driving distance, this is due to the property type, size and location, I had to extend search criteria to obtain sales and listings comparable to subject. The comparables used are still suitable comparables to subject property and market value is not affected. Used comparables over 120 days, although they vary in the sale date from inspection date, they are still considered reliable to subject property.
