This was expanded to up to 12 months in time, bed bath count, gla, style, view,pool,proximity up to 2 miles due to lack of similar homes. To obtain values in similar location of the subject it was necessary to use dissimilar bed/bath count comps. Subject is located near freeway//highway,commercials, pa rk,waterbody however it doesnot have any impact on the value. 




