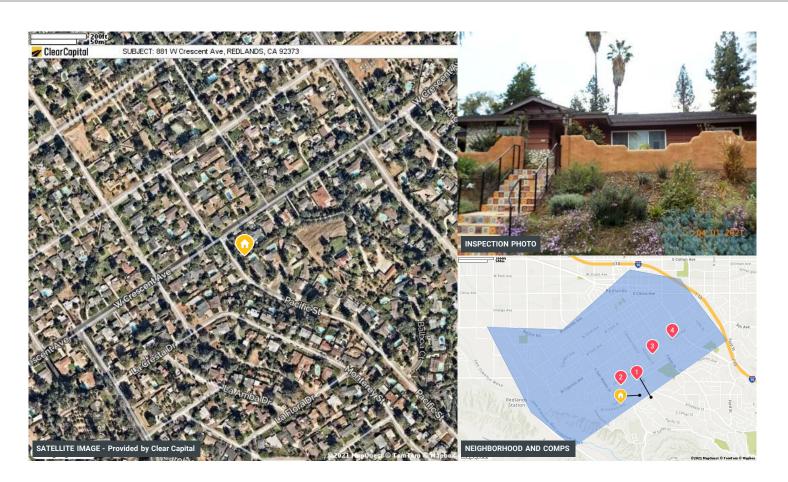

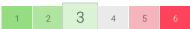

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

Value Conclusion + Reconciliation

All comps are from the subject's neighborhood and are recently closed. Comps 1 - 3 are located on less traveled roads. Comps 1 and 2 are less than 100sf different in GLA therefore, no adjustment is warranted. Comp1 is on a slightly larger site while comp 4 is on a smaller site. Comp1 is superior in condition/quality. Comps 2 and 4 per online photos are inferior in condition/quality. Most weight is given to comp 1 for its proximity.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

ADDITIONAL COMMENTS (OPTIONAL)

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$645k is considered reasonable as of 4/02/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.

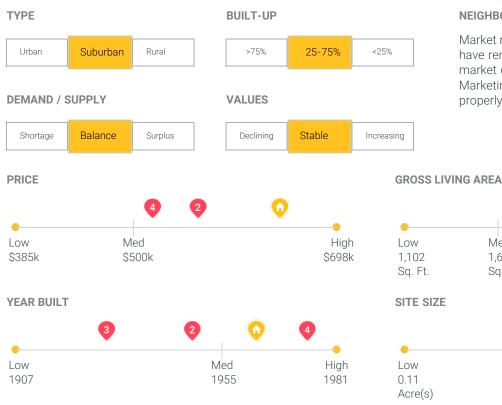
