### Sales Comparison Analysis

#### DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. Comps 1 and 2 are model matches and therefore, no GLA adjustment is warranted. Per online photos comp 2 is inferior in condition/quality. Most weight is given to comp 1 for its similarity and its timeliness.

#### EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

### Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$605k is considered reasonable as of 4/03/21.
