

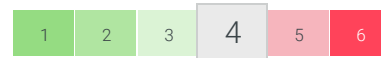

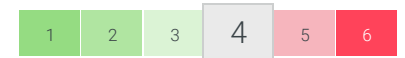

Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

A one mile radius search of detached homes was used.

EXPLANATION OF ADJUSTMENTS

The comps selected were from the subject's immediate market area and would be adjusted for differences in GLA, room count, garage, age and condition. #1 was included to bracket the subject's location. #1 would also adjust upward for inferior age/appeal and inferior GLA/room count. #2 and 3 had similar appeal age/appeal as the subject but would adjust downward for superior "usable" lot areas. #1 and 2 adjusted downward for superior condition/upgrades/features.

ADDITIONAL COMMENTS (OPTIONAL)

#3 had date of sale over 6 months from effective date but was included due to proximity, similar GLA and age. Values were rated stable, no time adjustments warranted. Comps 1 and 2 exceeded typical lender guidelines (10/15/25) but were included to bracket items in the report. No other more similar or competing comps found.

Reconciliation Summary

Most weight given to comp 3 as it was deemed most similar overall, with secondary weight given to comp 2 having very recent date of sale.

The purpose of this Appraisal Report is to determine an and the opinion of the market value for the subject property, at which it could sell in a typical exposure time for the area, considering current market conditions, the condition of the subject and necessary repairs.

SCOPE OF WORK:

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Rachael Hand, a licensed real estate agent having completed the above referenced Property Inspection.
