It was necessary to exceed the proximity by 2-mile even after relaxing GLA by +/-30% from the subject guidelines. The lot size and basement type were exceeded to keep the similar comparable within a 2-mile radius and 360 days sold to date. While doing the final valuation more weightage was placed on CS3 and LC2 as they are similar in the subject overall structure. The subject is located in the residential area of Fulton County and is closer to Worship, water bodies, and Park, and this will not have any negative impact on the market value of the subject.

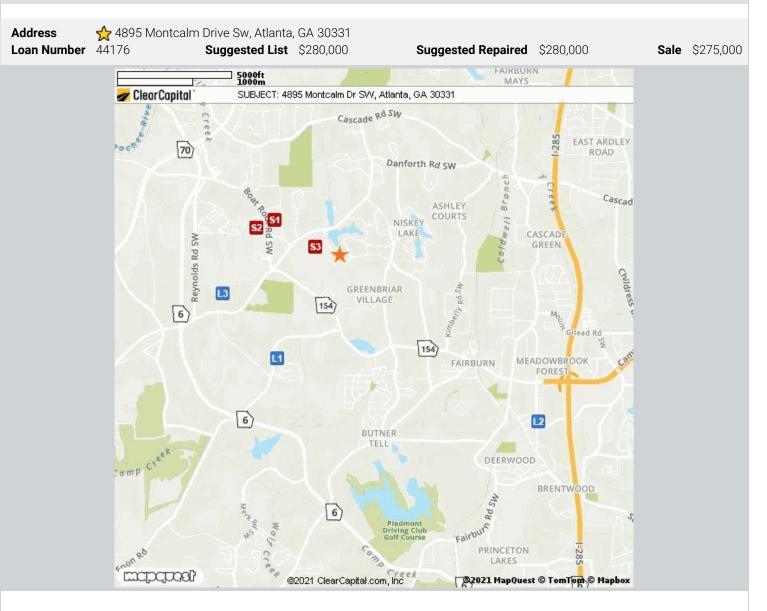
