<p>Our market is increasing- SFR increased 13.1% in sales price since this time last year, while condos/townhomes saw an increase of 10.3% in sales price. Inventory is less than a month supply. Distressed sales remain historically low, accounting for only 1.2% of sales. Cash sales account for about 21% of recent sales. Days on market are also low- roughly 81% of homes sell within 60 days. The suggested list price is based upon comparable sales used in account with current market conditions. Also based on exterior inspection only- interior condition could dramatically affect the value of the property.</p>

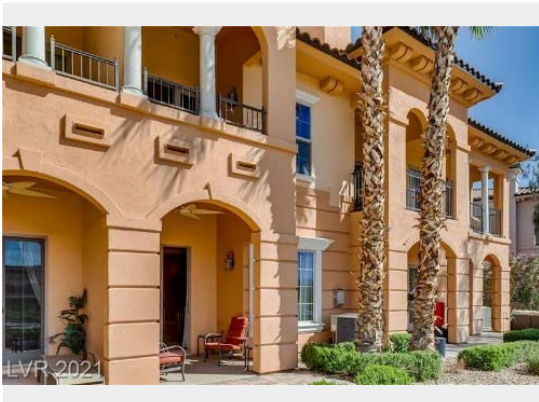
