<p>As per recent MLS condition subject is good condition and no repairs noted. As long as the subject is priced within the market value of the most recent similar comps within the subject property's area there should not be a problem with resale. Within 1 mile, 20% GLA +/-, Year built 20 +/-, there were limited comparable available in the subject neighborhood. Therefore it was necessary to exceed closed date, style, year built, lot size and proximity exceeded up to 0.90 miles. Due to lack of comparable it was necessary to use comparable with variance in style for active and sold comps. List differ by more than 10 years in age but are still felt to be reliable Comparable. Subject has 2/0 bath. Within 1 mile there were no similar bath comparable available. Due to the unique characteristic in subject bath count it was necessary to use comparable with variance in bath count for active comps. In delivering the final valuation, most weight has been placed on CS2 and LC2 as they are most similar to the subject condition and overall structure. The subject property is located near to residential area, park, worship, main roads and other commercial. Due to limited comparables, some comparables were taken crossing the highway. This however, will not have effect on value and marketability. The details were taken as per the tax record.S1 received multiple offers which resulted in an increased final sale price relative to list price/original list price. As per the active MLS attached along with the report subject is in in renovated condition hence the subject is considered to be in good condition.</p>

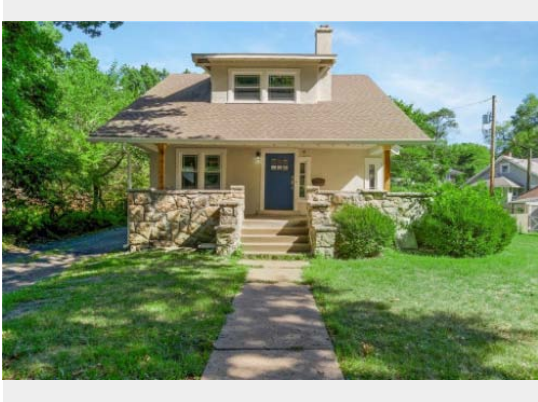

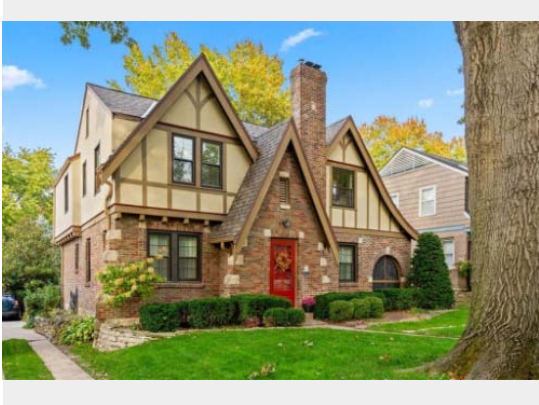

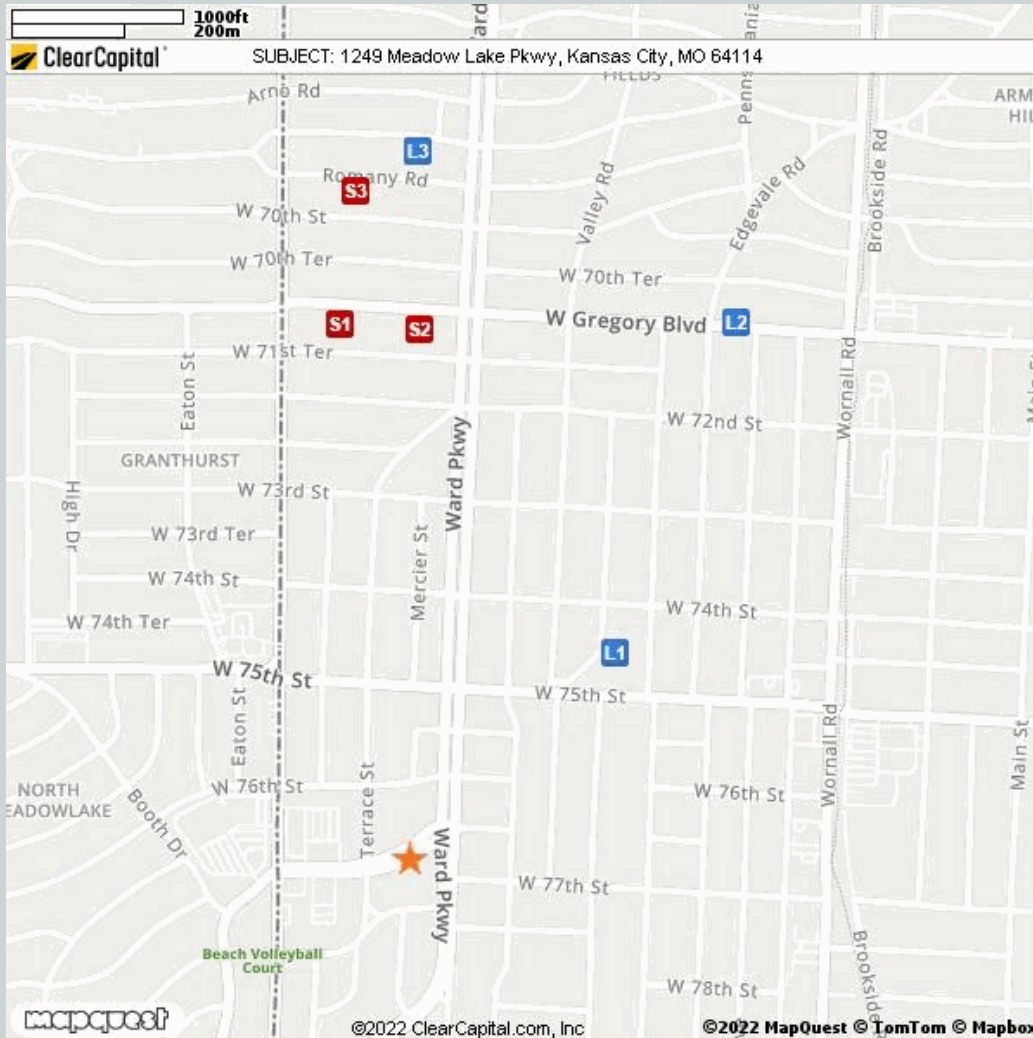
