Comments Regarding Pricing Strategy

The subject property is a single family home, which is in overall average condition on the exterior. The interior of the subject property was not inspected for this report, and is assumed to be in average condition. The subject's recent MLS Listing does not include any interior photos. The distance searched for similar comps was 1.5 Miles and the time searched was 12 Months time. Listing comps were searched for slightly beyond 1 Mile to locate properties similar in GLA and other attributes. It was necessary to search beyond 3 months time for sold comps as there were limited recent similar sales in this area. The GLA Tolerance searched for comps was +/- 20% of the subject's GLA. The subject is in average exterior condition and emphasis was placed on using comps which were also in average condition. However, this market area is saturated with comps which have updating and remodeling. In addition, there are limited comps which support the subject's GLA and other attributes. 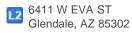

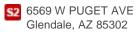

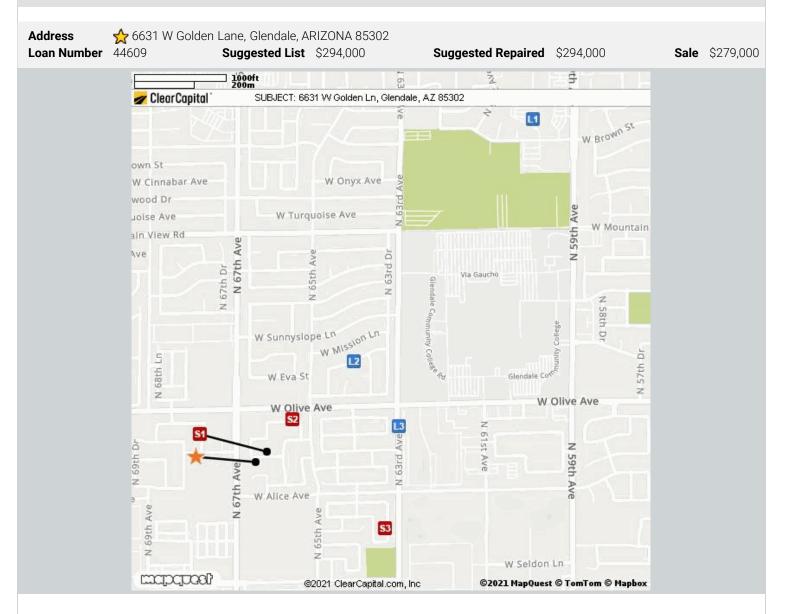
