Listing 1 Adjustments: GLA Above: \$20.00 / sqft, GLA Below: \$5.00 - Finished \$2.00 - Unfinished, Lot: .10 / sqft, Garage: \$1,500 / Stall, Bathroom: \$1,500, Condition: \$5,000 / Level, Age: \$500 / Ten Years. This comp is about equal due to the slightly larger above grade GLA being offset by the age and the lack of a basement.

Listing 2 This comp is inferior to the subject property due to the smaller above grade GLA despite having a slightly larger below Grade GLA.

Listing 3 This comp is inferior due to the smaller above grade GLA and the age despite having a finished larger below grade GLA.

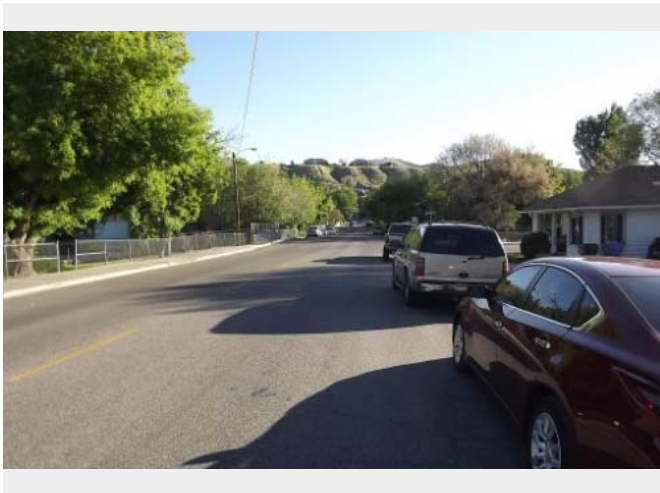

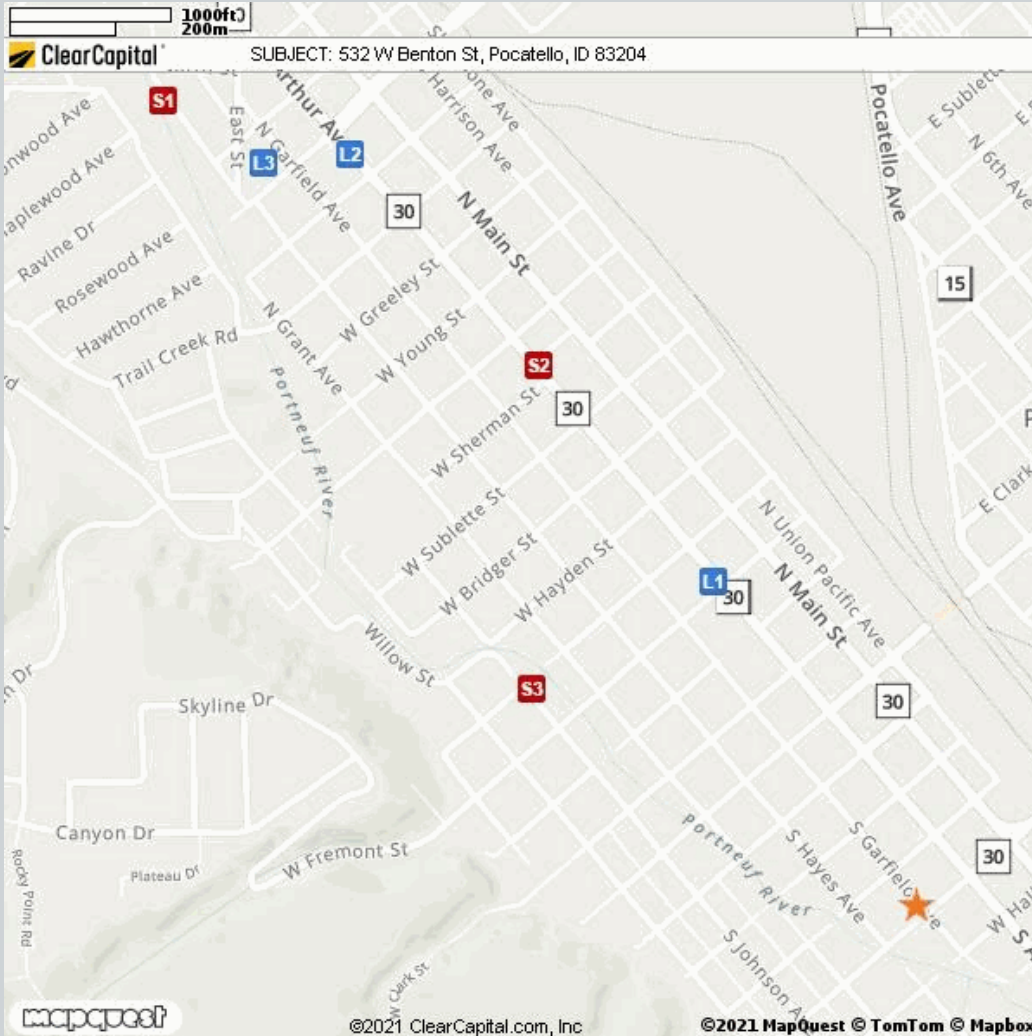
