#### **Comments Regarding Pricing Strategy**

Pricing suggestion came about from analyzing the most current comps which are located as close to subject as possible and are as close as feasible in square footage, location, condition, style and acreage with subject property. I have searched a distance up to 1 mile, GLA +/- 20% sqft, lot size 30% +/- sq ft, age 20% +/- yrs and up to 3 months in time. This was expanded to up to 12 months in time, proximity upto 1.1 miles, GLA, pool, view, lot size, year built, style due to lack of similar homes. Subject is located near freeway/highway, railway line, school, commercial; however it does not have any impact on the value. To obtain values in similar location of the subject it was necessary to use dissimilar bed/bath count comps and I have provided appropriate adjustments for those variance. It was also necessary to use a comparable from the other side of the highway. Comps even though they are divided by the highway, the division does not have an impact on the value. Since there were limited comparables available within subject's market neighborhood, it was necessary to expand the market research beyond +/-25% GLA and year built. Sold comp 1 and Listing comp 3 was the most weighted comps in Location and gla.






