#### Comments Regarding Pricing Strategy

The search was extended back 12 months, out in distance 5 miles, and even with relaxing 35% GLA search criteria, I could not find many comps that fit within 20% GLA requirements and similar style and appeal. Within 5 miles and back 12 months, I found 6 comps, of which I could only use 6 due to condition or site-size factors. The comps used are the best possible currently available comps within 5 miles, and the adjustments are sufficient for this area to account for the differences in the subject and comps. Upon review of all the pertinent information, an opinion of the as-is market value of \$310,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore, no resale issues are foreseen.

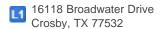

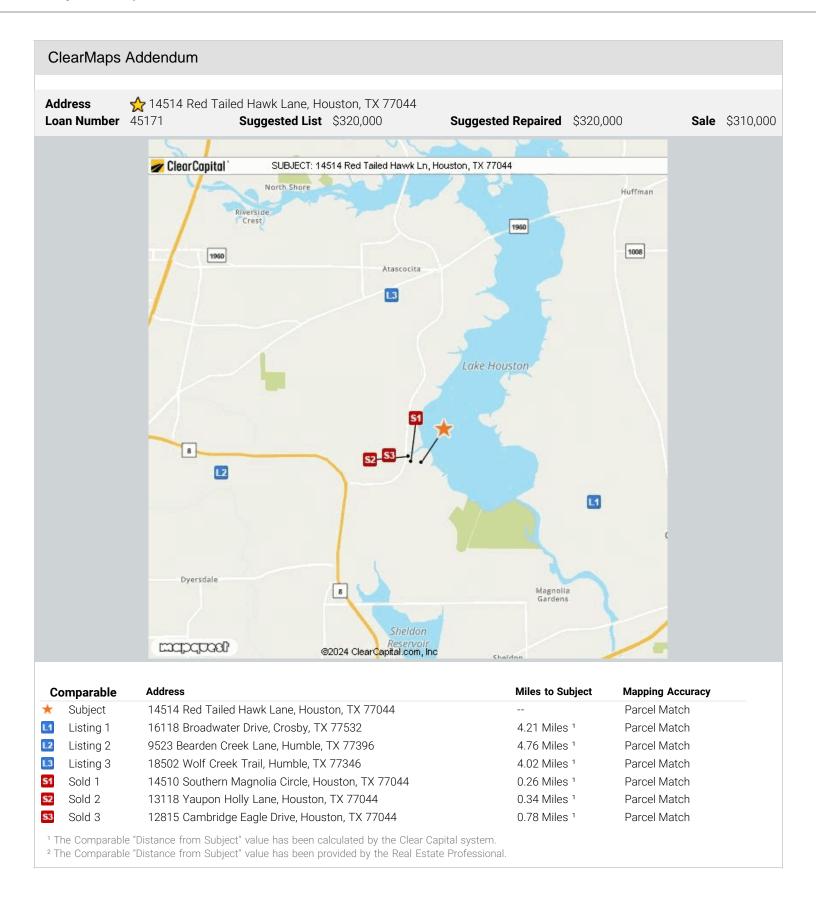
