Listing 3 Represents an active good condition comp at the upper end of this neighborhood. The subject would compete below this.

Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller room count and needing TLC. Overall, similar in design and appeal and has comparable views. Adjustments: \$3000 due to room count, -\$3000 due to carports, \$10,000 due to needing TLC.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$1380 due to sq ft, \$407 due to the lot, -\$200 due to age, \$3000 due to room count.
- Sold 3** It also has the same view as the subject, but its updates, having a carport, and having a larger lot makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: \$3480 due to sq ft, -\$333 due to the lot, \$400 due to age, \$6000 due to room count, -\$3,000 due to carport, -\$25,000 due to updates.

<p>Listings: MLS# 96702054/ 8718 Cowart St was considered but because this comp reflected a value very different than the rest of my comps, it was replaced with comps that better supported the market and my final value conclusion. Note: Commercial and Industrial Influences, freeway, train tracks, open spaces, and busy roads in the immediate vicinity of the subject will not negatively influence the marketability and value of the property. The lack of available comps in the immediate neighborhood of the subject made it necessary to expand the search to use comps with smaller GLA. Chronological age and site-size differences do not have a significant effect on value. Upon review of all the pertinent information, an opinion of the as-is market value of \$126,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.</p>

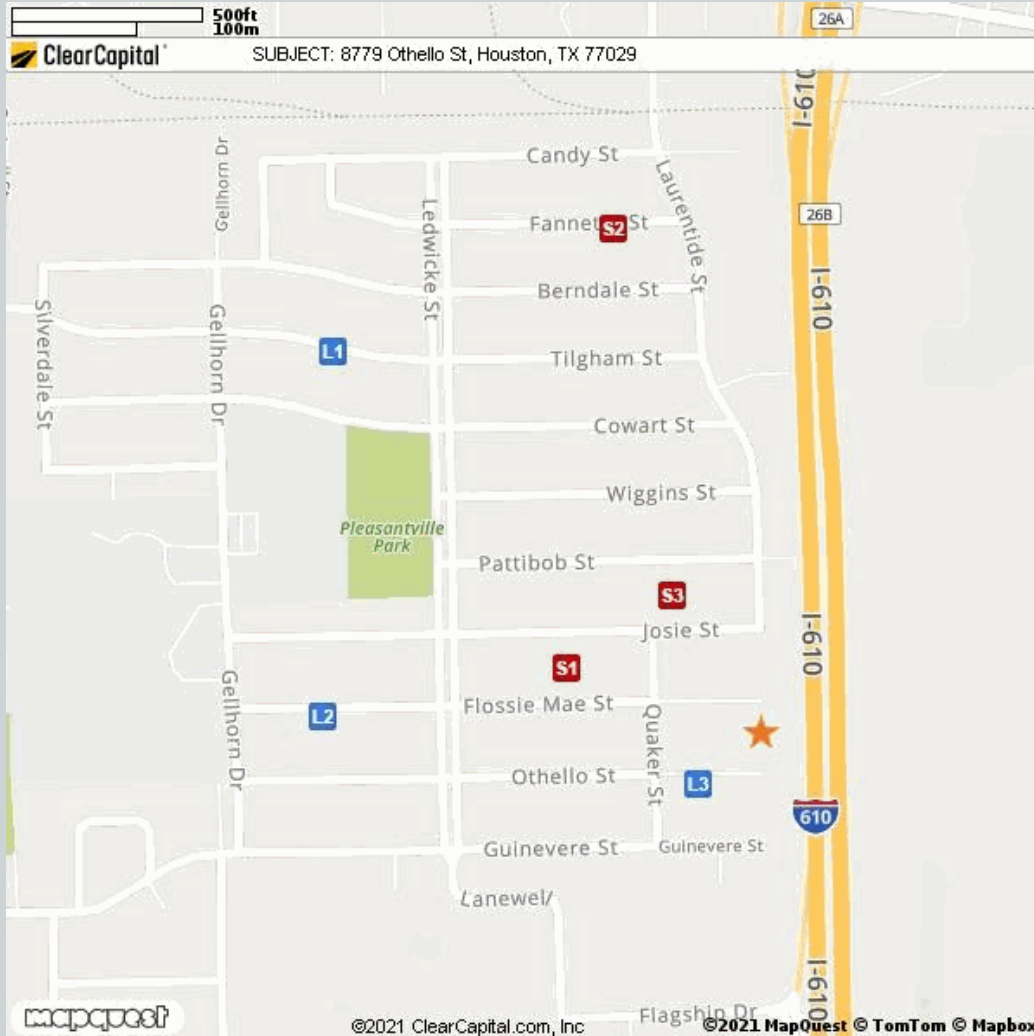
