

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

Value Conclusion + Reconciliation

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. Comp 4 is less than 100sf different in GLA therefore, no adjustment is warranted. Per online photos comp 2 is superior in quality while comp 3 is superior in condition/quality. Most weight is given to comp 2 for its similarity.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$1,200,000 is considered reasonable as of 7/19/21. 




