Most of the similar comparable in the subject neighborhood is renovated or having updates, Due to limited availability of similar conditions comparable, I was forced to use compared with some minor upgrades. Sale #2 exceeds 6 months on date of sale but used due to stable market conditions. Subject is located near commercial building, park and busy main roads. This will not affect the market ability of the subject. In delivering final valuation, most weight has been placed on CS2 and LC2 as they are most similar to subject condition and overall structure. 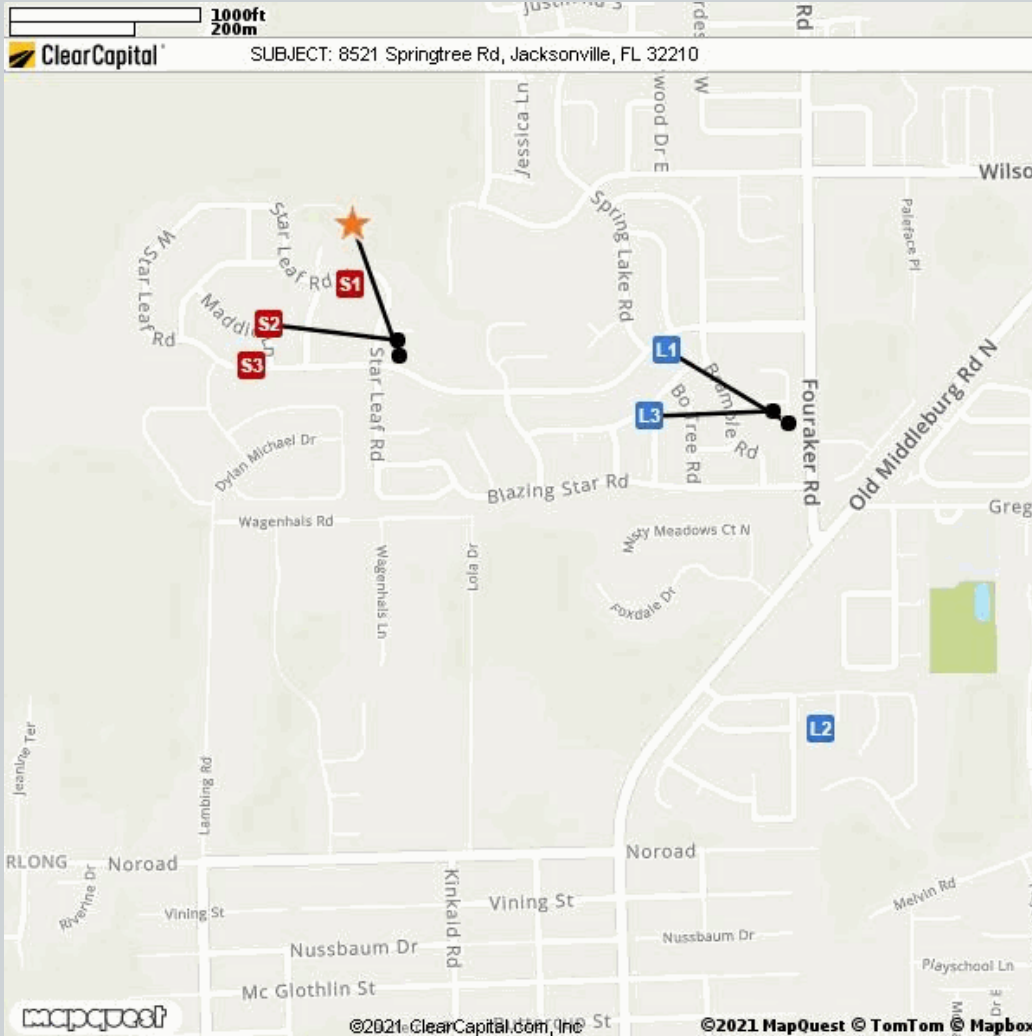
