Comments Regarding Pricing Strategy

Based on the exterior observation the subject is in average condition. All maintenance appears to be up to date and no repairs are necessary based on the exterior inspection. Within 0.50 miles, 20% GLA +/-, sale date to 3 months, Year built 20 +/-, there were limited comparables available in the subject neighborhood. Therefore it was necessary to exceed the closed date to 12 months, lot size. In order to stay closer proximity, active comps were not bracketing the GLA(used superior) as they are still considered to be reliable comparables. The comparable selected were considered to be the best available. The value and marketability will not be affected with the subject being located near a residential area, worship, school, park, RR track, busy street, commercial area. Due to limited comparable from same subject location, it was necessary to use comparable from across the major roads, but from the similar neighborhood. It will not affect the current market value of the subject. In delivering the final valuation, most weight has been placed on CS1 and LC1 as they are most similar to subject condition and overall structure. The subject details are taken from the tax record.




