Prices are rapidly increasing as the area has a shortage of homes on the market, combined with very few REO/shortsales. The subject was strategically priced mid-market because all homes were from the same/similar subdivisions, and were of similar GLA, age, style, and lot utility. 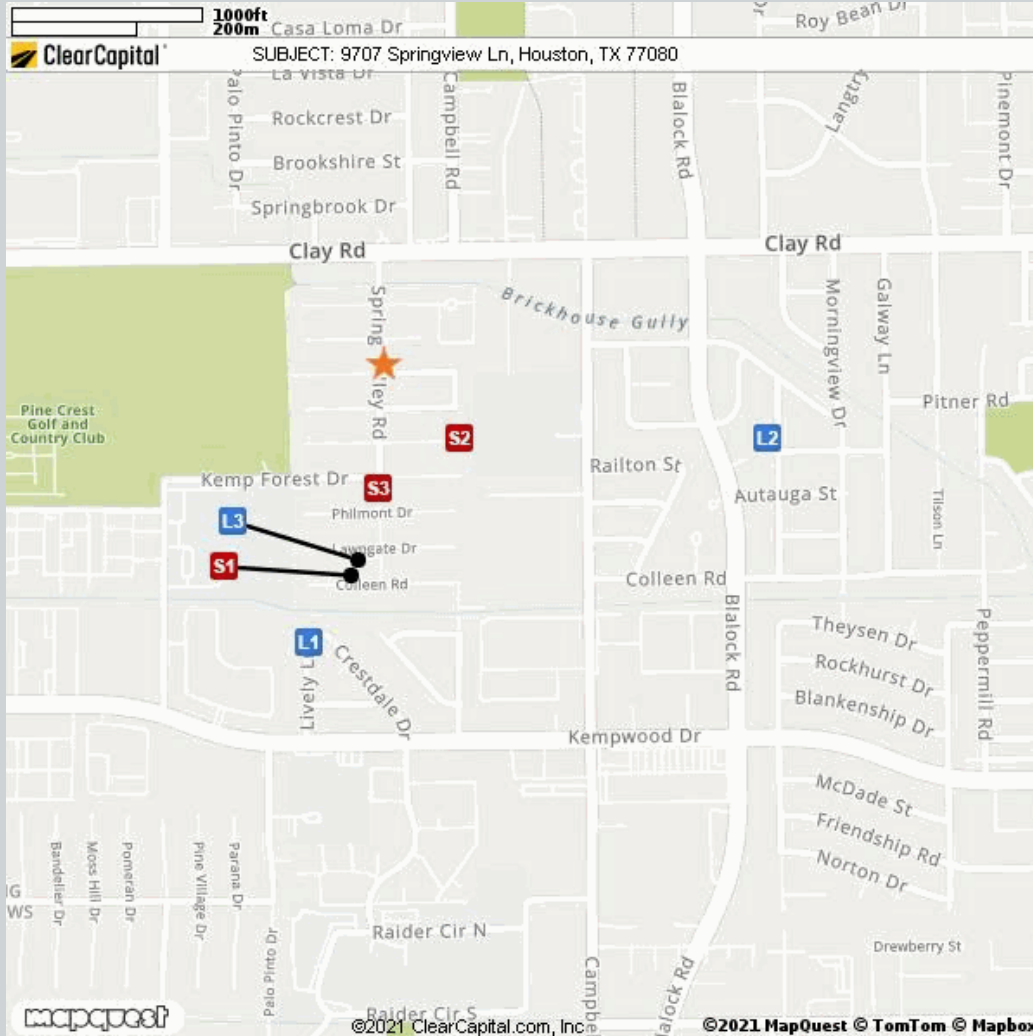
