All the comps chosen are GLA range within 25% sqft, within 1 miles proximity, 12 months sales period. Due to a lack of comparable's with similar attributes in closer proximity search for comps had to expanded in distance and sold date. Due to the limited comps in the area it is necessary to use comps that are outside of the value variance. The comp is still valued correctly and is an accurate reflection of the local market value.</p>

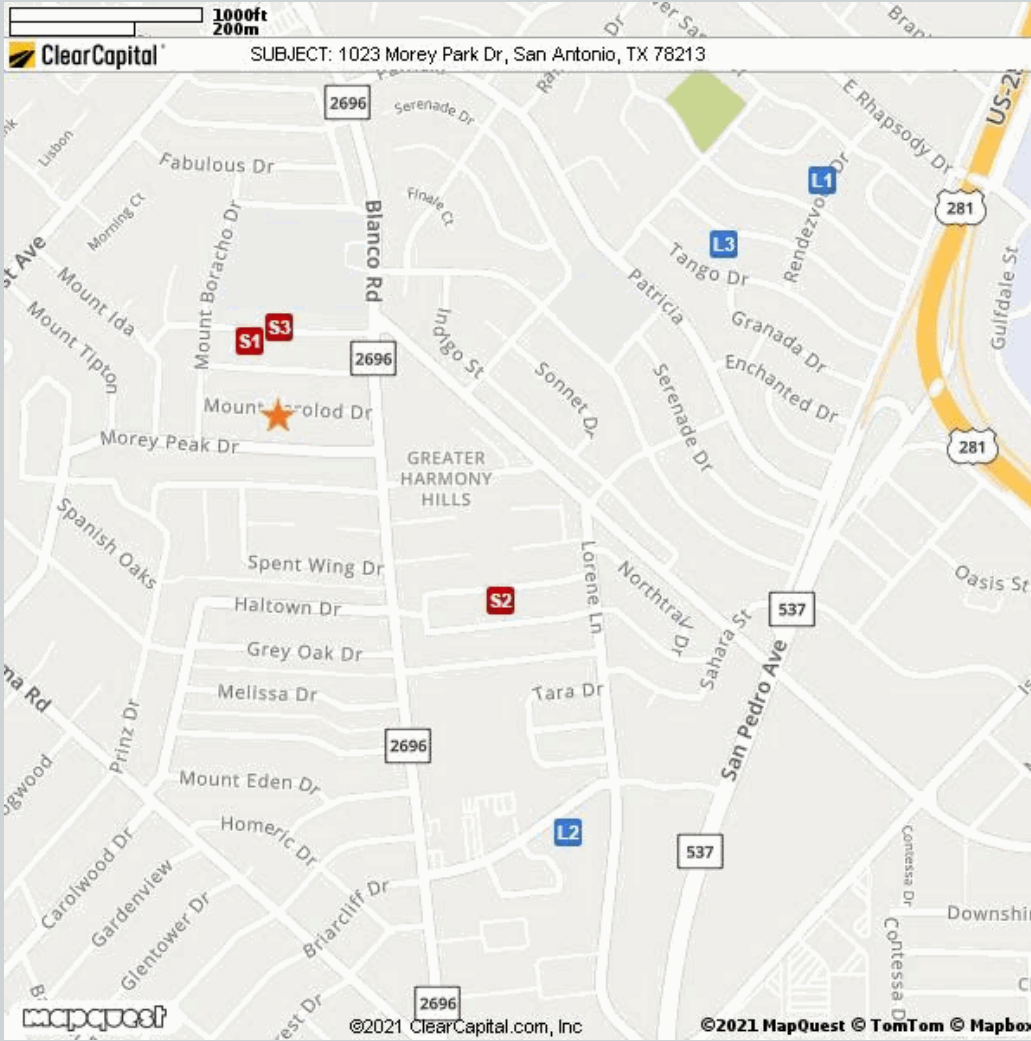
