<p>Subject recommended pricing is based on the best of the comparable properties in the immediate market area. Pricing is based on those comparables used in this report which are closer to the subject in proximity and most similar in terms of GLA, age, lot size, other features, and amenities. Search for comps was done using a 1-mile radius, 30% difference in gla, 25 years difference in age, and a 360-day close date. Comparables used in this report are the best available at the time of inspection and represent the immediate market scenario. Due to a lack of listing comparable properties in the area, it was necessary to use comps with variance in +/- 20 years, expanded back 360 days from the current date, +/- 30% of the subjects gla. Similar styles, also locations, and conditions were considered due to limited comps in the immediate area.</p>

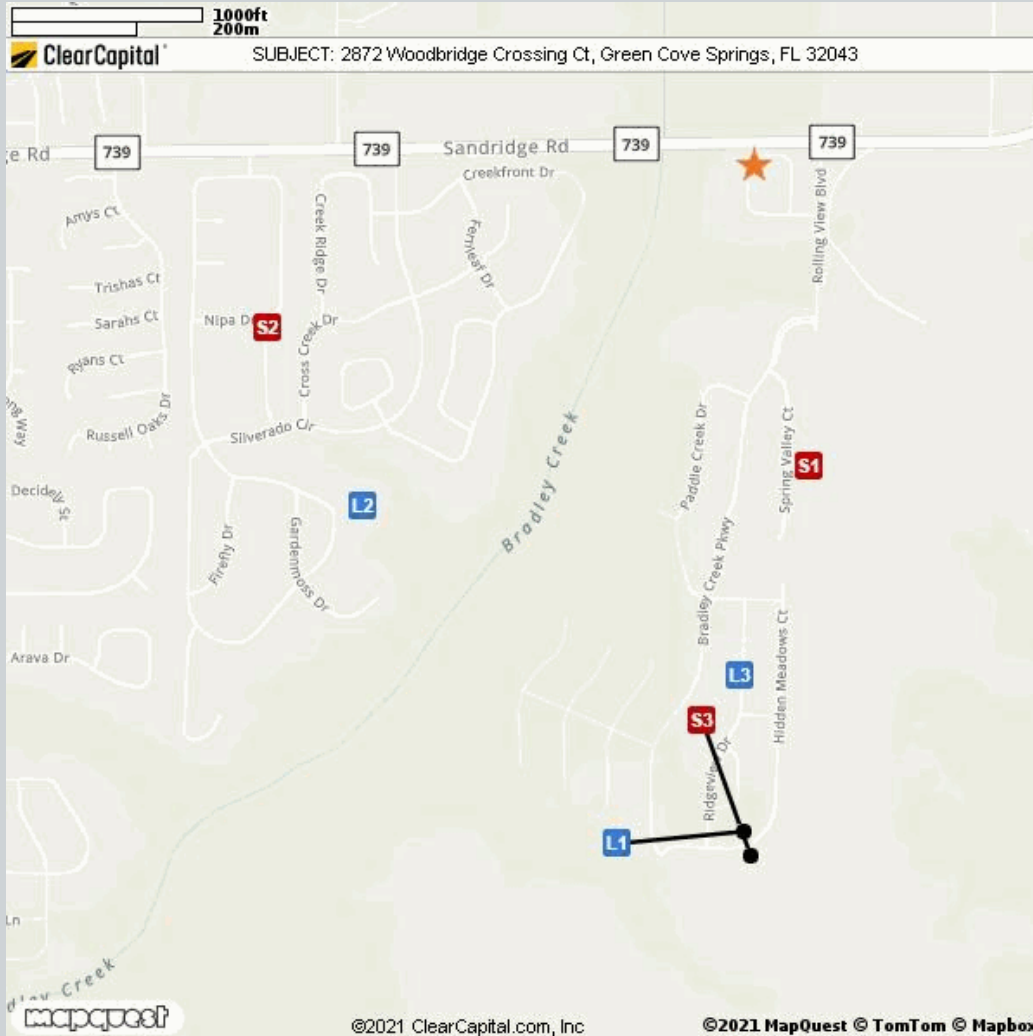
