I have searched a distance up to 1 mile, GLA +/-20%, year built +/- 20 and up to 6 months back. To get enough comparables, it was necessary to exceed bed/bath count, condition, and lot size. Since there were limited comparables available within the subject's market neighborhood, it was necessary to use sold comparable with a sale date beyond 90 days from the date of this report. In delivering the final valuation, the most weight has been placed on CS2 and LC2 as they are most similar to the subject condition and overall structure. 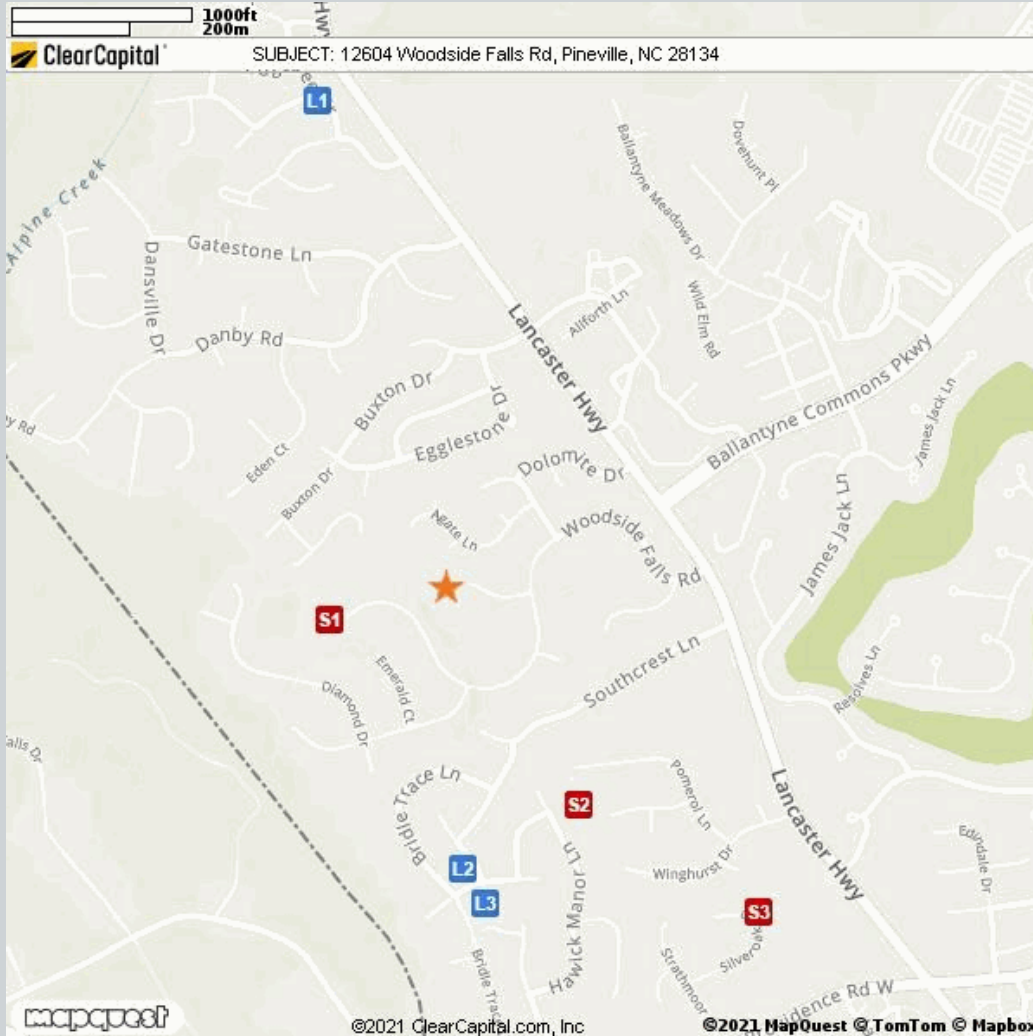
