

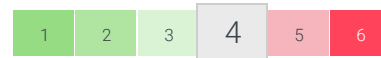

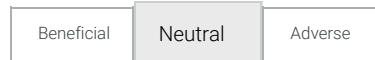

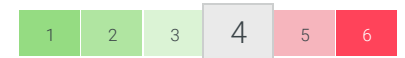

Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

A one mile radius search of detached homes was used.

EXPLANATION OF ADJUSTMENTS

The comps selected are from the immediate area and were adjusted for differences in GLA/bath count and condition. #2 was adjusted downward for newly good/remodeled condition. Adjustment based on market data from this immediate area. #3 was adjusted upward for time based on available statistical data with comps 1,2 having more recent dates of sale and no adjustment warranted. #3 had date of sale over 6 months but was included to bracket GLA. #3 also adjusted upward for inferior deferred maintenance based on available data. Most weight given to comp 1 as it was deemed most similar overall.

ADDITIONAL COMMENTS (OPTIONAL)

#2 exceeded 10% line item and 15% net adjustment due to superior remodeled condition but was included

Reconciliation Summary

Most weight given to comp 1 due to fewest adjustments and comp 3 due to more similar GLA.

Scope of Work



REPORT FORMAT:

The purpose of this Appraisal Report is to determine an and the opinion of the market value for the subject property, at which it could sell in a typical exposure time for the area, considering current market conditions, the condition of the subject and necessary repairs.

SCOPE OF WORK:

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records. Although the appraiser did not physically inspect the subject property, at a minimum the appraiser has considered the results of a recent visual property inspection completed by Bon Nguyen, a licensed real estate agent having completed the above referenced Property Inspection.
