Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of being an older building and needing TLC. Overall, similar in design and appeal and has comparable views. Adjustments: -\$1695 due to sq ft, -\$684 due to the lot, \$600 due to age, \$10,000 due to needing TLC.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: \$1995 due to sq ft, -\$451 due to the lot, \$600 due to age, -\$10,000 due to updates.
- Sold 3** It also has the same view as the subject, but its larger GLA, being a newer building and having updates make this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$1200 due to sq ft, -\$171 due to lot, -\$800 due to age, -\$25,000 due to updates.

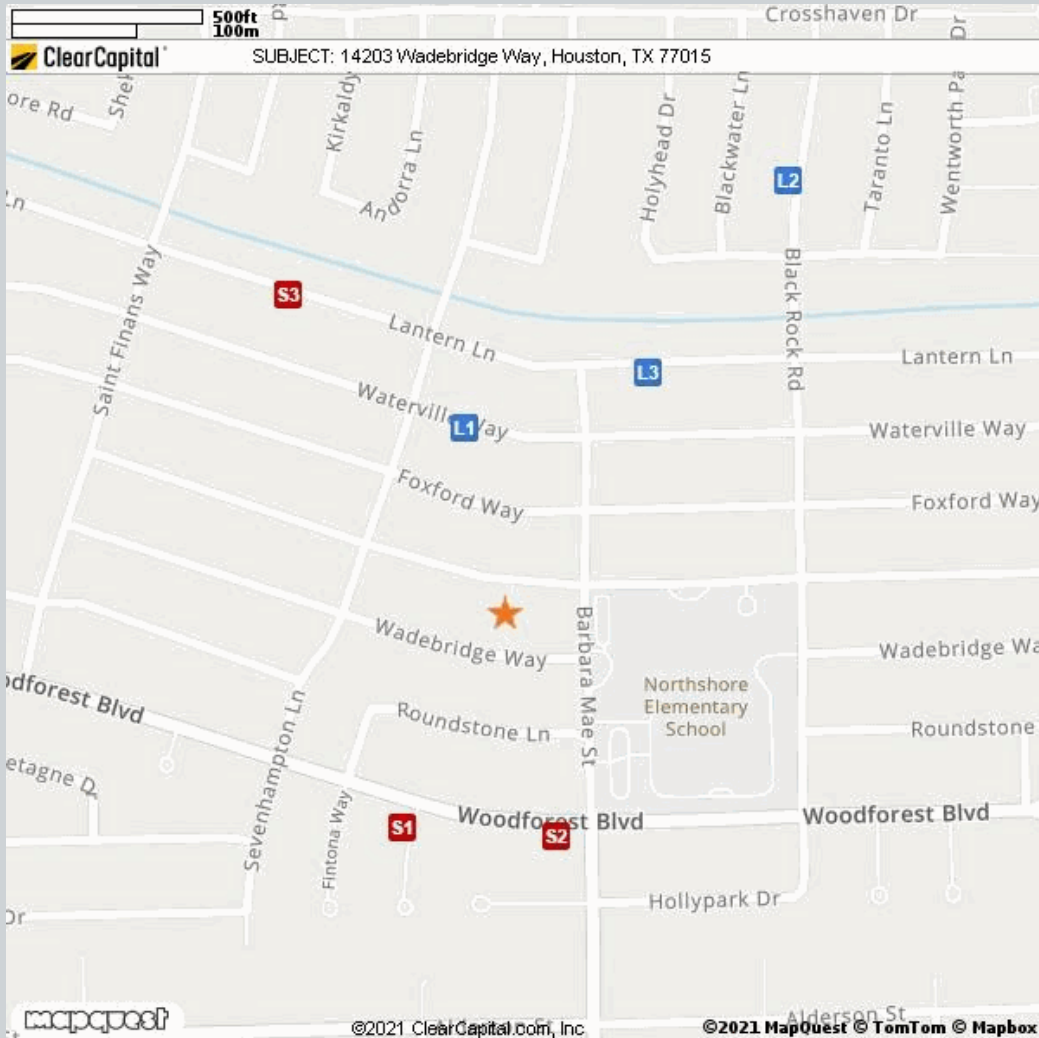
