These tend to sell higher as they are in a gated neighborhhood and all brick. Fair market comps from the same neighborhood, block or subdivision are used whenever possible. The sales and listing search revealed comps were that had similar size and features and are located in the closest possible vicinity to the subject. Search parameters start at 1 mile and closer and expand out as needed. Comp sale date starts at 180 days and earlier. GLA search starts at 15% smaller or larger of subject and increases only if necessary. Lot sizes vary in the subject market. It is not always possible to bracket the subjects lot size. 
