<p>Subject is in the vicinity of water but this doesn't have any effect on subject's marketability. Subject is in the vicinity of a school, a busy road and commercial properties. This could have a negative effect on subject's marketability. There has been little activity in subject's immediate neighborhood in the last 3 months. In my previous report, I was a little too conservative compared to aggressive market in surrounding neighborhoods. My value conclusion is based on CS1 and current market increase. I gave most weight to CL3 and CS1 which is similar to subject in overall appeal and condition. The Anticipated Sales Value (ASV) given should allow subject to get under contract within 90 days. Final value conclusion given is based on Fair market value. It was necessary to expand beyond DATED COMPS and CONDITION guidelines due to limited comps in subject's immediate neighborhood. Please note that I was forced to use Good condition comps due to proximity. The comps used are the best possible currently available comps within 1.0 miles and the adjustments are sufficient for this area to account for the differences in the subject and comps.</p>

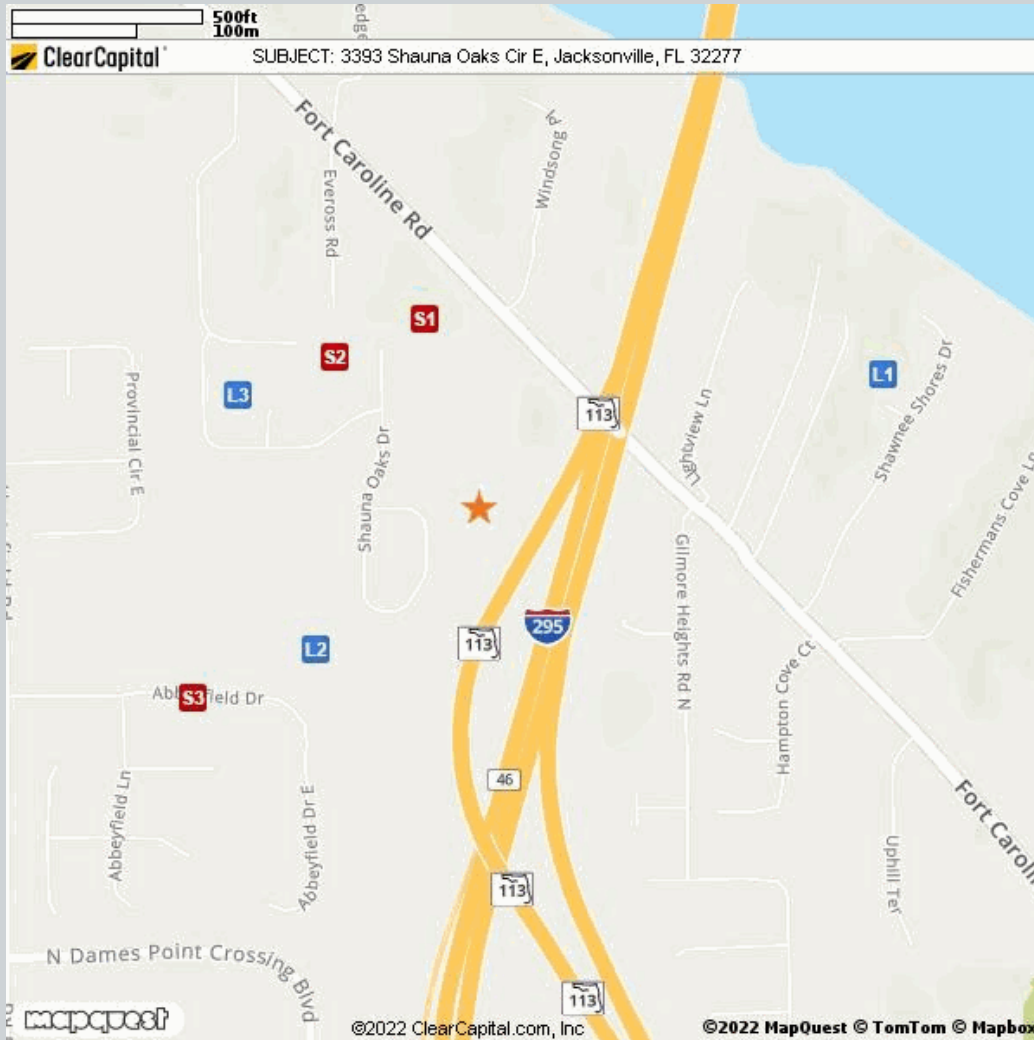
