### Sales Comparison Analysis

#### DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. Comps 2 and 3 are less than 100sf different in GLA therefore, no adjustment is warranted. Per online photos comps 2 and 3 are superior in condition/quality. Most weight is given to comp 3 for its similarity

#### EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. Net/gross adjustments are within the standard 15%/25% guidelines. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.


#### ADDITIONAL COMMENTS (OPTIONAL)

Comp 1 was listed on 9/9/2021 for \$649,900.

### Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$520,000 is considered reasonable as of 9/12/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.

## Scope of Work
