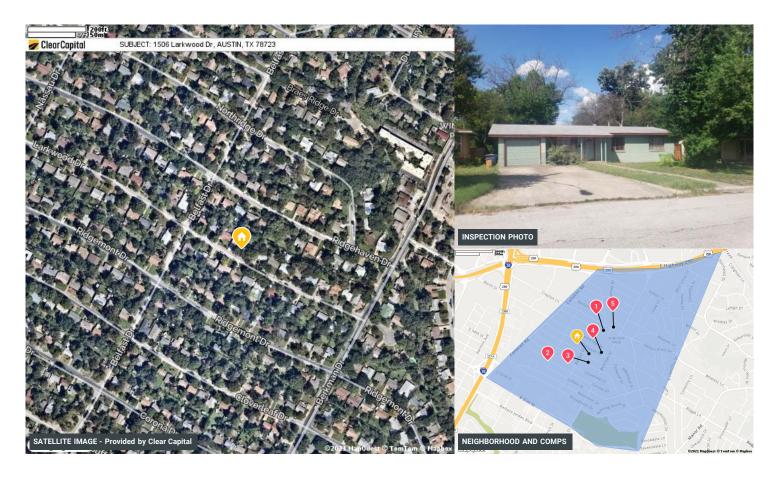

### Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

A search was conducted within the subject's neighborhood market for homes that offer 3-4 bedrooms, 1-2 full baths, built between 1948 and 1990 and offer GLA between 1,200 and 1,700 SF. A total of 39 properties were located with 12 listings and with 27 closed sales.

EXPLANATION OF ADJUSTMENTS

Adjustments were considered at \$75 per SF for GLA over 50 Sf difference, \$2,500 for half baths, and \$2,500 per garage space.

### Reconciliation Summary

After consideration for differences, the adjusted sale price range fell between \$525,675 and \$558,000 with the subject's value supported at \$545,000 with weight given to all of the comparables.

Appraiser Commentary Summary

I have not personally inspected the subject property. The scope of the inspection included an exterior inspection of the property by a third party identified on the inspection report. The condition was determined by reviewing the observational data within the inspection report. An extraordinary assumption is made that this information is correct. The subject was viewed from the exterior only and found to be in average/livable condition with no observable deferred maintenance. The subject offers 3 bedrooms, 2 baths and a12 car garage. The interior is assumed to be in average and livable condition with the subject assumed occupied at the time of inspection. Data on the subject's bedroom counts is mixed. The subject is assumed to offer 3 bedrooms with 98% of the homes this size offering 3 bedrooms only.

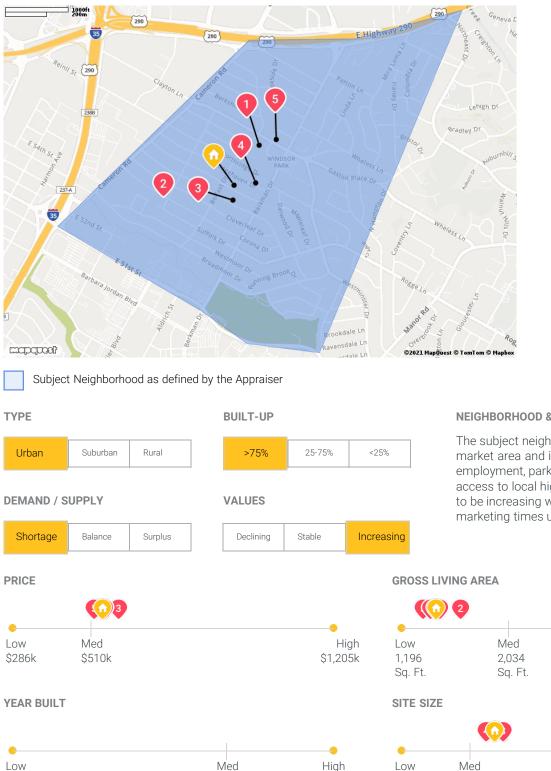

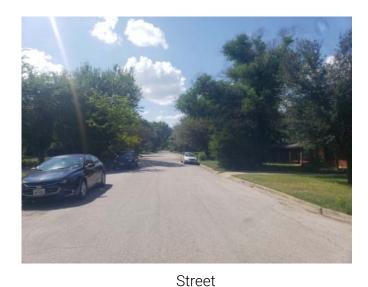

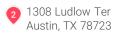

### Scope of Work
