<p>The values are based on the current market trend in this area. Values have increased due to economic conditions over the past months on all property in this area. In this current market value provided are based on recent sales and listings in this area taking into account the current market trends and value variance. The subject is a SFR containing 1919sqft, 3bed/2bath, which was built in 1973 and is located near highway, railway track, park and commercial area and will not affect the subject. It was necessary to exceed the proximity of the comparable because within 0.25 mile there were only 2 comparable availability with 3 months sold date, so it was exceeded sale date upto 6months and also proximity upto 0.5 mile. It was necessary to exceed the lot size variance guideline of 25% in an effort to use the best available comparable from within the subject"s market area. The garage count was verified through MLS data and photos. Due to lack of comparable in the subject's same side it was necessary to exceed major boundaries such as major roads, highways, freeways, etc and will not affect the market value. In order to bracket the subject"s GLA and lot size, a search for comps was broadened to include a wider price range. Value is derived from an emphasis on sold comp 1 and list comp 2 , as they are most similar to subject condition and overall structure.</p>

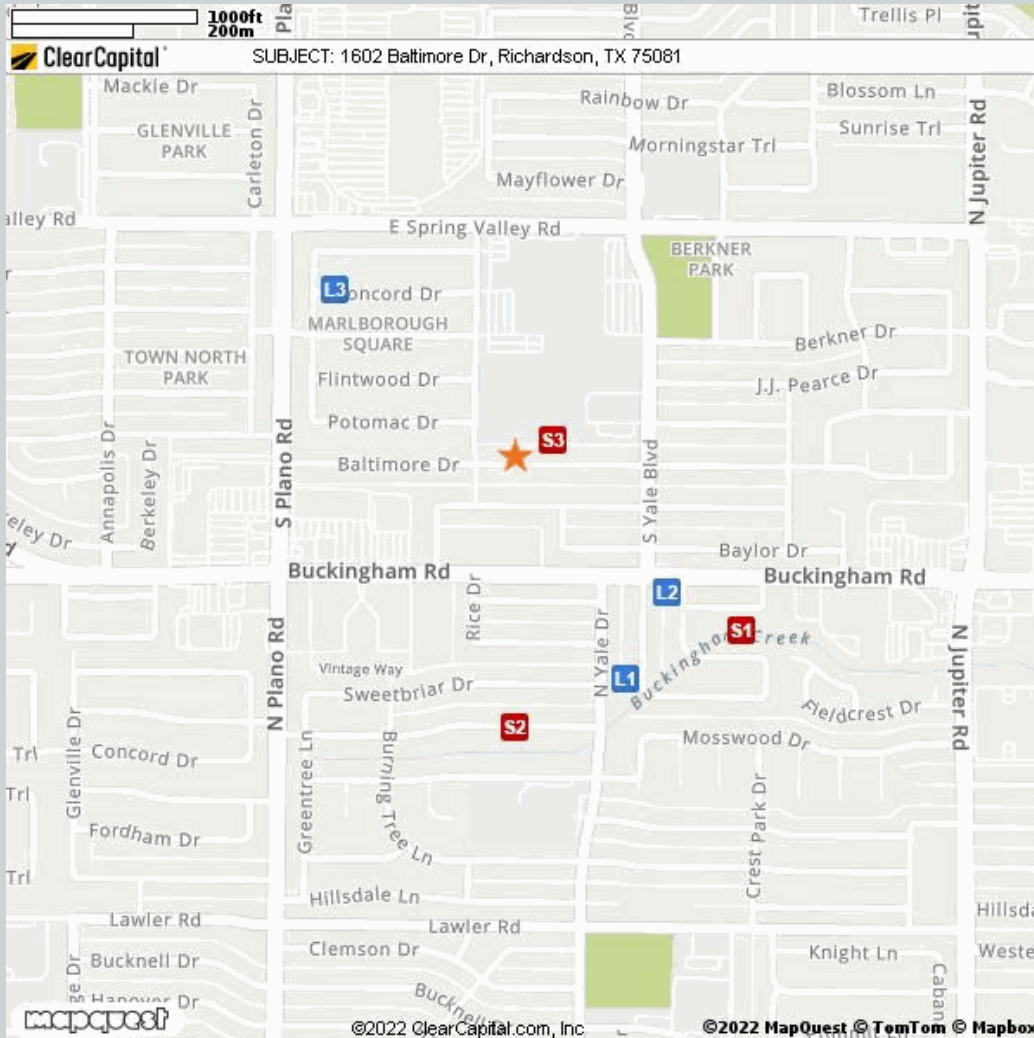
