Subject is a single family detached home lies in a suburban area. The Subject appears to be in average condition based on exterior inspection. The comps were chosen based on the following criteria - GLA, proximity and condition. Sale period, room count, age and location were also considered while choosing comps for the report. All the comps chosen are within 25% GLA variance, within 2 miles proximity, 12 months sales period. Due to a lack of comparable with similar attributes in closer proximity search for comps had to be expanded in distance and sold date. The comps are still valued correctly and are an accurate reflection of the local market value. Search criteria had to be expanded to accommodate comps which match the subject's GLA and other attributes and which points towards a best value estimate.




