Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and for having a smaller room count. Overall, similar in design and appeal and has comparable views. Also farthest in proximity to the subject compared to other comps used. Adjustments: \$930 due to sq ft, -\$1744 due to the lot, \$1200 due to age, \$1500 due to room count, -\$5000 due to updates.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$5115 due to sq ft, -\$1275 due to the lot, \$600 due to age, -\$3000 due to room count, -\$5000 due to updates.
- Sold 3** It also has the same view as the subject, but its larger room count, having updates, and having a larger lot make this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: \$1065 due to sq ft, -\$1982 due to the lot, \$600 due to age, -\$3000 due to room count, -\$20,000 due to updates.

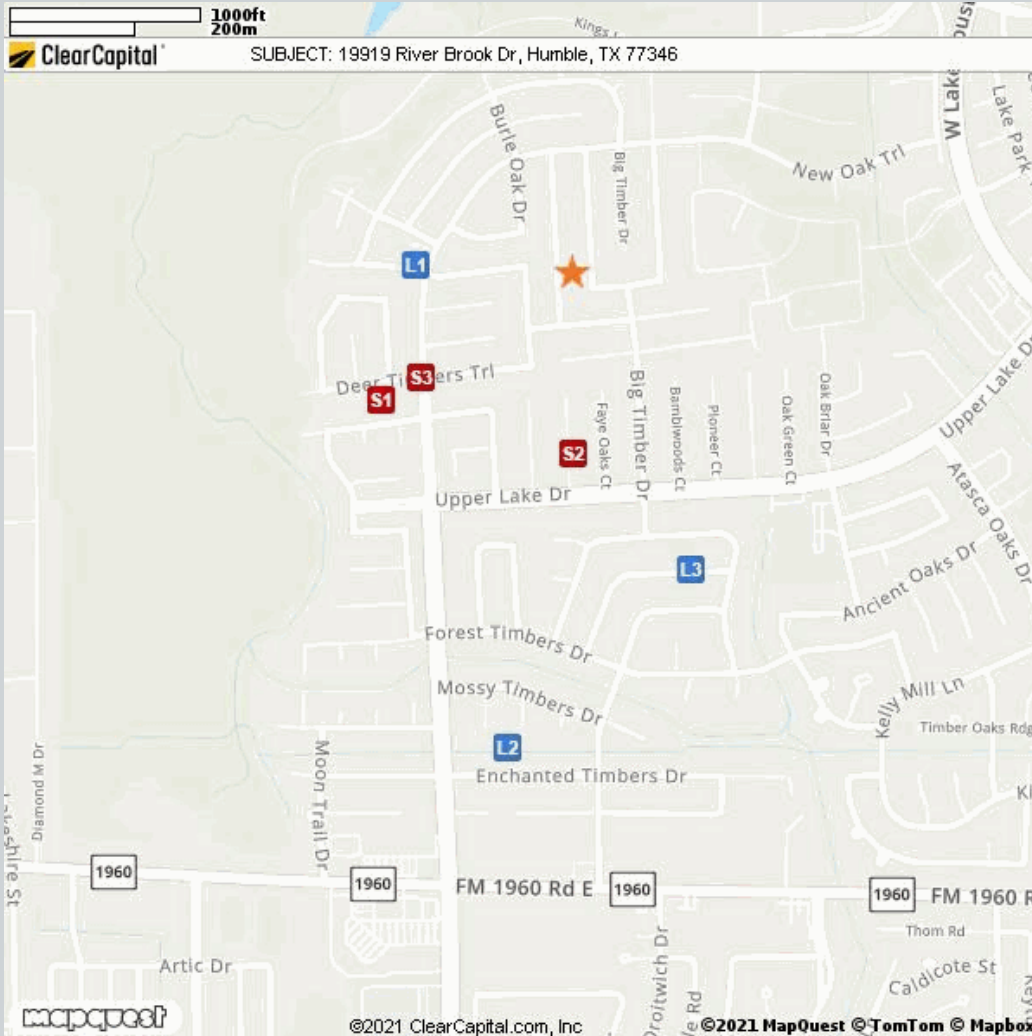
