<b>Comments Regarding Pricing Strategy</b>		
<p>The subject property is a 1 story Ranch, 1894 square feet, built-in 1981, containing 3 bedrooms and 2 bathrooms. The exterior inspection revealed that the subject has been adequately maintained and considered to be in average marketable condition. To maximize the accuracy of initial valuation, we have elected to increase the time span of closed sales past the favorable 6-month window to find comparables that required the fewest net adjustment. It was necessary to exceed the lot size variance guideline of 20% in an effort to use the best available comparable from within the subject's market area. Property is located near busy roads, water bodies and commercial centres, comparable shares values defining qualities with the subject in regard to age, GLA, location and condition so the subject location characteristics don't affect its marketability. The difference in bed count due to the neighborhood area hard to find comparable that is similar to the subject in condition and GLA. In delivering final valuation, the most weight has been placed on CS2 and CL1 as they are most similar to subject condition and structure.</p>

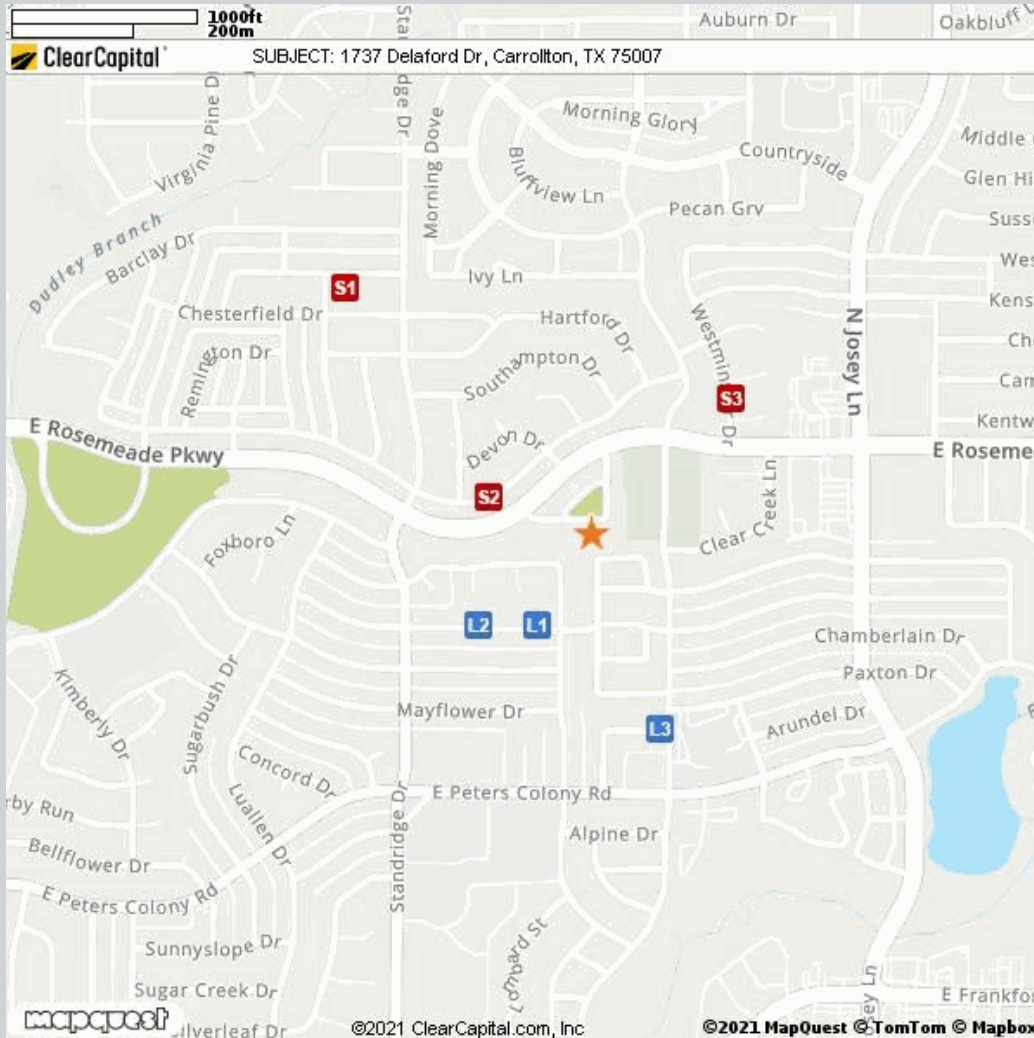
