Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

All comps are from the subject's neighborhood and are recently closed. The appraiser chose the best comparables available. Limited available data due to the subject's condition and GLA. Comps 3 - 4 are less than 100sf different in GLA therefore, no adjustment is warranted. Per online photos comps 1 and 3 are slightly superior in condition/quality while comp 2 is superior in condition/quality. Comp 4 is a SFR that was included for its similar condition and is given the least weight in this analysis. It is on a larger site and lacks the view of the subject. Most weight is given to comp 1.

EXPLANATION OF ADJUSTMENTS

Amenity differences have been adjusted properly and are deemed customary for the area. No negative external factors were noted which would negatively impact marketability. Value appears to be adequately supported.

ADDITIONAL COMMENTS (OPTIONAL)

Net/gross adjustments exceed the standard 15%/25% guidelines for comp 2 due to its condition/quality which was unavoidable.

Reconciliation Summary

After reconciliation of the supplied comparables, a value estimate of \$600k is considered reasonable as of 9/16/21. Extra ordinary assumptions were made in terms of interior condition/finishes, room count, etc. The comparables sales are acceptable and appear to be competitive in age, GLA and appeal to the subject.
