The effort was made to bracket the subject in all major features and categories such as GLA, lot size, year built, location, and date of sale. Unfortunately, the most similar sales sold over 6 months ago. However, a time (date of sale) adjustment has been applied to the comparable sales based on the data put forth by the California association of realtors which is close to 20% increase in the last year and a half.

comp 3 has the most adjustments being on a much smaller lot and newer than the subject. The least weight has been applied to this comparable.



This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records.
