Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and for being an older building. Overall, similar in design and appeal and has comparable views. Also farthest in proximity to the subject compared to other comps used. Adjustments: \$420 due to sq ft, -\$300 due to the lot, \$1000 due to age, \$6000 due to room count, \$3000 due to no carport.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$1740 due to sq ft, \$300 due to the lot, \$3000 due to no carport.
- Sold 3** It also has the same view as the subject, but its larger GLA, having updates, and having a larger lot makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$2445 due to sq ft, -\$5130 due to the lot, \$1500 due to room count, \$3000 due to no carport, -\$2500 due to 1-car garage, -\$5,000 due to updates.

<p>Note: Commercial Influences, train tracks, open spaces, and busy roads in the immediate vicinity of the subject will not negatively influence the marketability and value of the property. The lack of available comps in the immediate neighborhood of the subject made it necessary to expand the search to use comps with larger lots. Chronological age and site-size differences do not have a significant effect on value. The distance traveled for comps is farther than preferred; however, it was necessary to and it is typical for the area. The search was extended back 12 months, out in distance 6 miles, and even with relaxing 35% GLA search criteria I was unable to find many comps that fit within 20% GLA requirements and similar style and appeal. Within 6 miles and back 12 months, I found 13 comps of which I could only use 6 due to condition or site- size factors. The comps used are the best possible currently available comps within 6 miles and the adjustments are sufficient for this area to account for the differences in the subject and comps. Upon review of all the pertinent information, an opinion of the as-is market value of \$150,000 is adequately supported with emphasis placed on List No. 2 and Sale No. 2. Based upon an exterior inspection, from the street, the subject property has no observable adverse condition noted that would cause a safety or health risk/concern at the time of inspection. Therefore no resale issues are foreseen.</p>

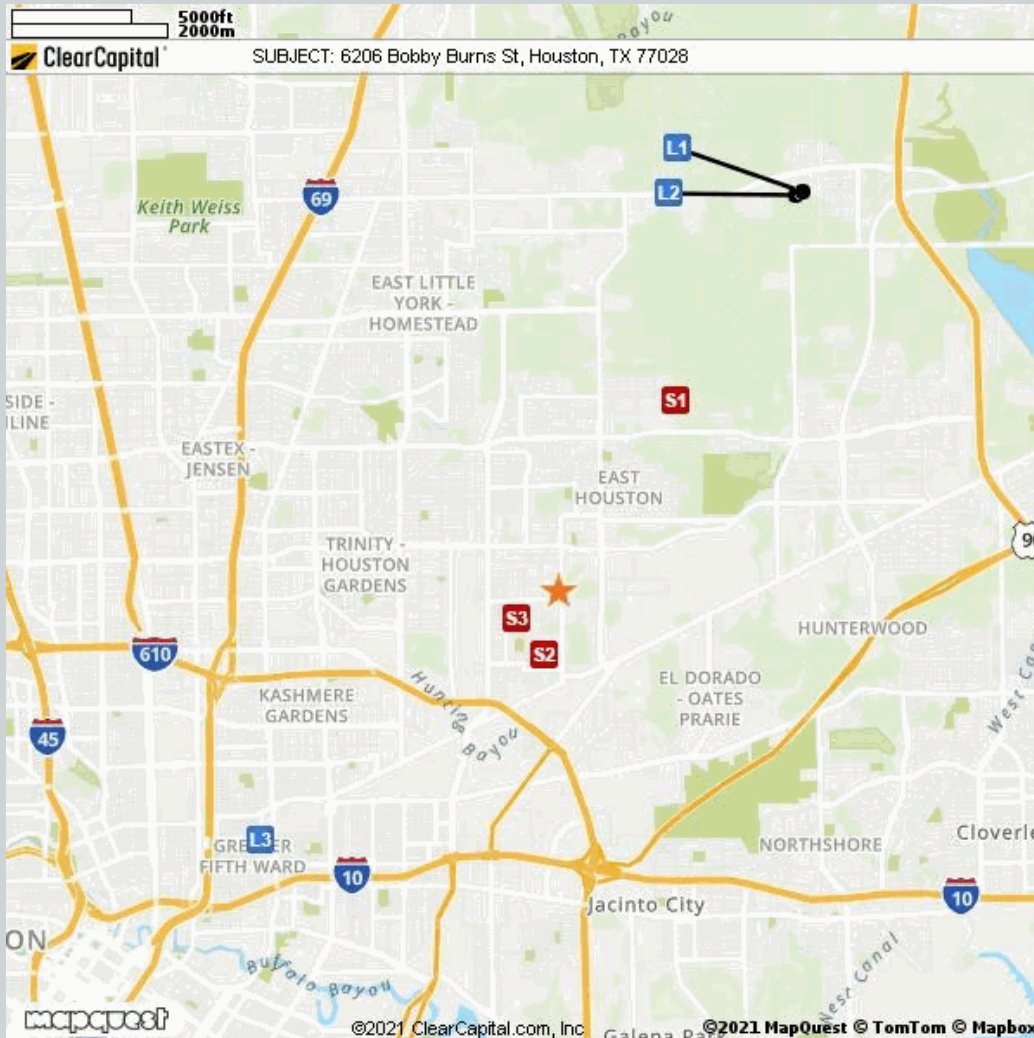
