Adjusted for larger SF (-\$5175), carport (-\$1500), larger lot (-\$400). Multiple offers drove SP higher than LP with no concessions paid.
- Sold 2** Regular resale. Search expanded to find similar comps. Similar location value, neighborhood makeup. Slightly larger SF, similar age, exterior style, features, lot size, garage. 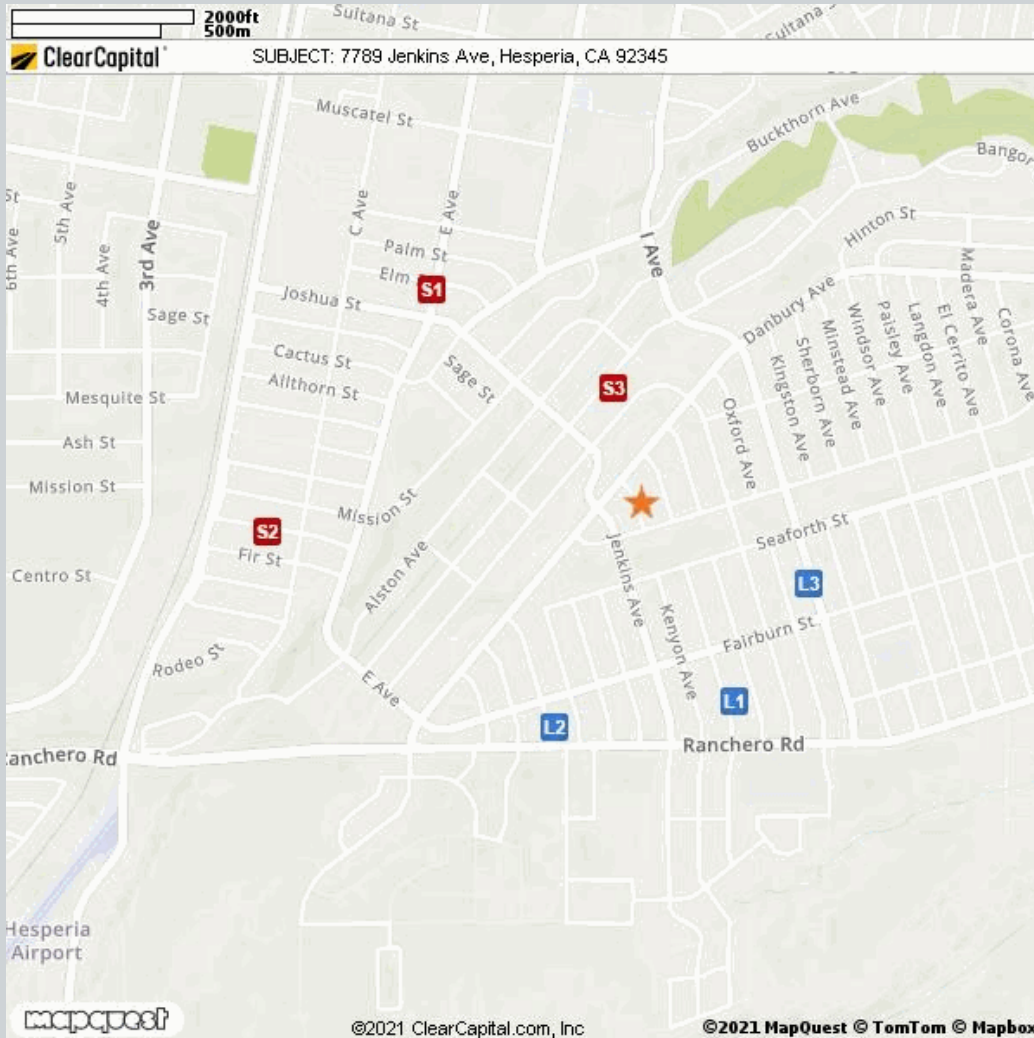
