<p>The subject is a single family home built in 2016 contains 3 beds and 2baths, subject details taken from tax record. Subject in an average condition. The subject is located next to highway, river, commercial area, rail track, park, school, worship center, retail amenities and other facilities. Due to lack of comparables within subject same side it was necessary to cross major boundaries such as major roads, and river, which won't affect its marketability. Within 1 mile +/-30% Gla, there were only 2 listings available, hence proximity was exceeded up to 2 miles. The subject is unique in its lot size to the neighborhood, hence comparables with inferior lot size are used in the report. To locate comparable which is similar to subject attributes style, half bath count, garage count and sold date 6-12 months were exceeded. Due to limited comparables within the subject market Gla for sold comparables were not bracketed. Sold comparable 1 and list comparable 2 were given the most weightage in the final analysis.</p>

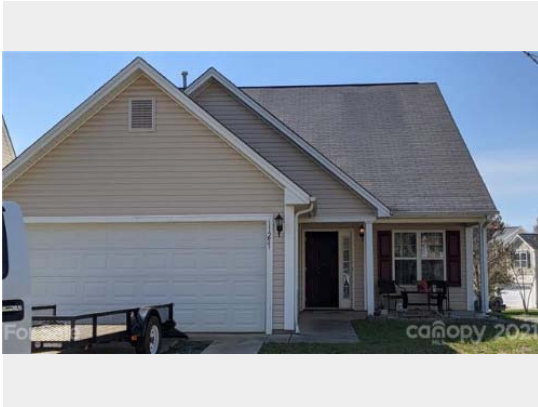

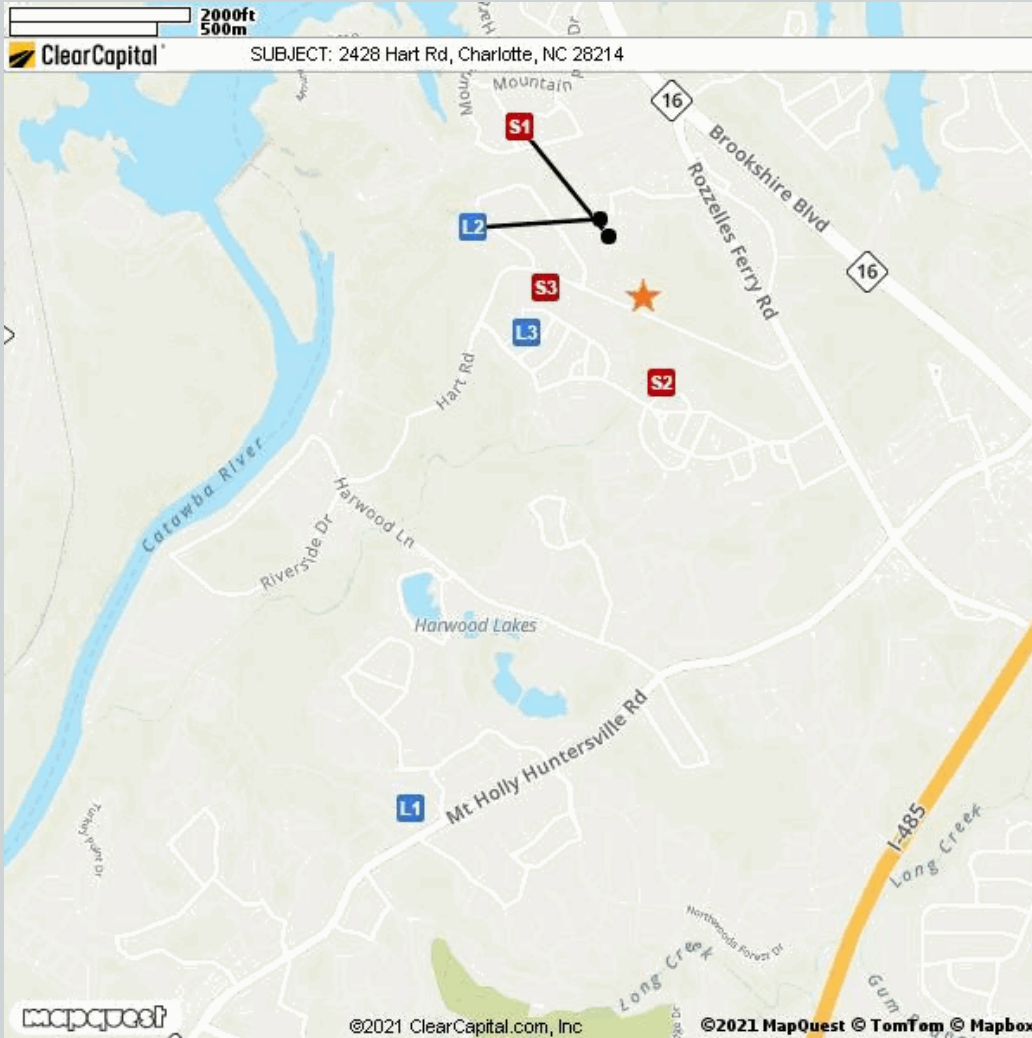
