However, this will have no impact on value. In delivering final valuation, the most weight has been placed on CS1 and LC1, as they are most similar to subject condition, and overall structure.</p>

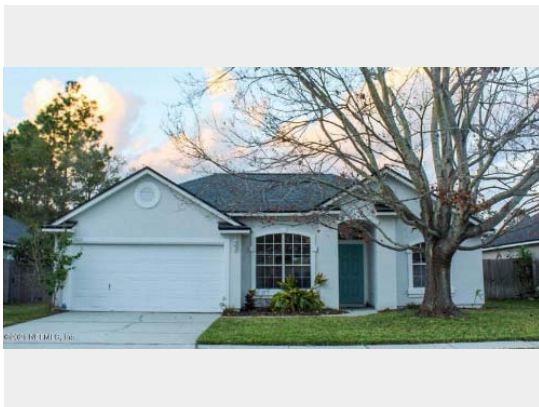

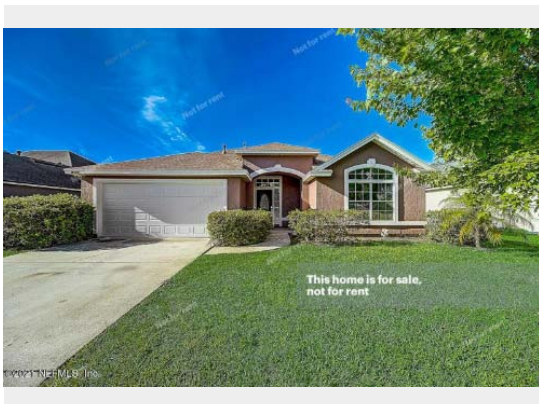

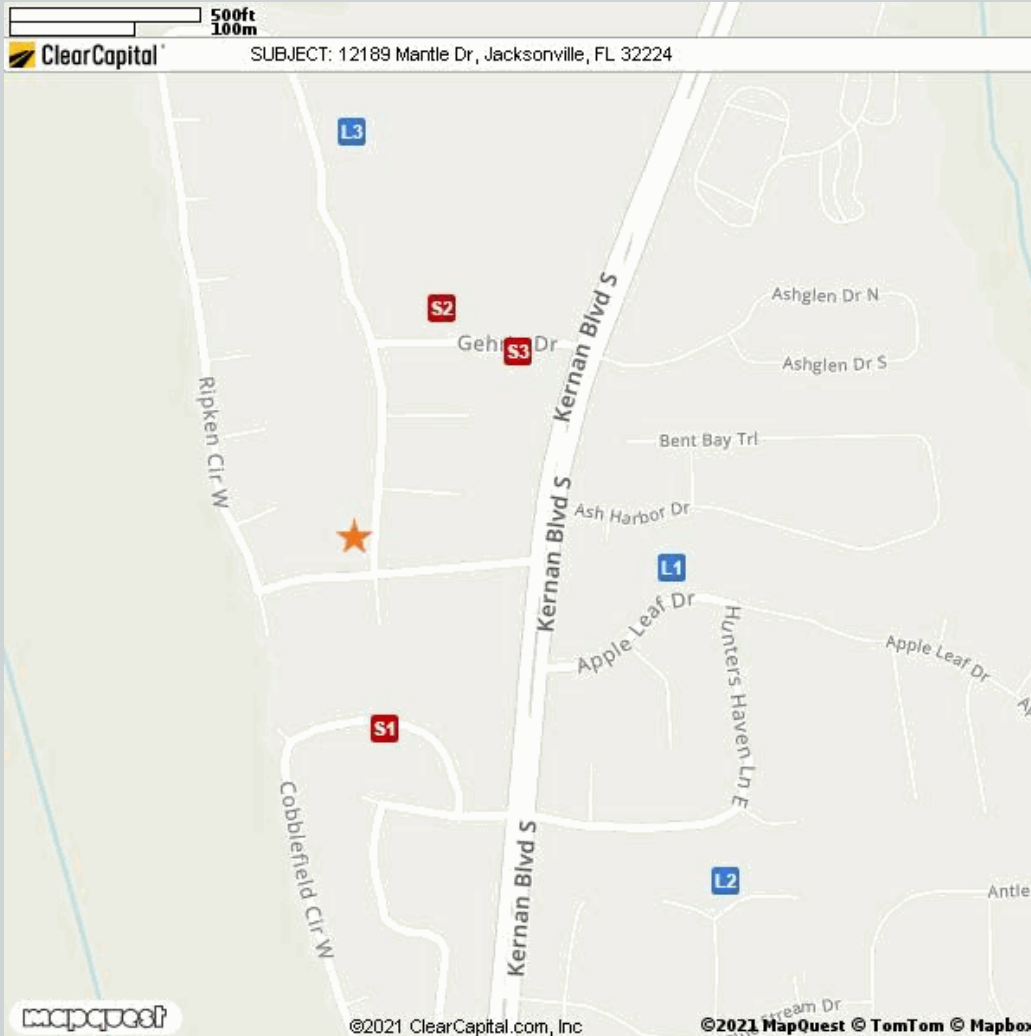
