<p>The sale and listing search Comps for this report are within a GLA range of 1686 to 2580 Sq. Ft., within 1 mile radius, 1957 to 1977 Year built, 12 month sale date time. Proximity parameters were exceeded and search was extended up to 1 miles as there were limited comparables are available within 0.5 mile. To locate more proximate comparable the limitations on acceptable price range were exceeded. The exterior of the subject appeared to be in average condition. To stay within subject neighborhood need to exceed bed, bath count, GLA, style and lot size guidelines. Since there were limited comps available, I was forced to choose all comps exceeding 3 months sold comps Subject is located near park, golf course, highway and commercial. Comparables crossed major roadways and support subject value and had no impact on marketability. In delivering final valuation, most weight has been placed on CS2 and LC1 as they are most similar to subject condition and overall structure. Subject attributes are taken from tax record attached.</p>

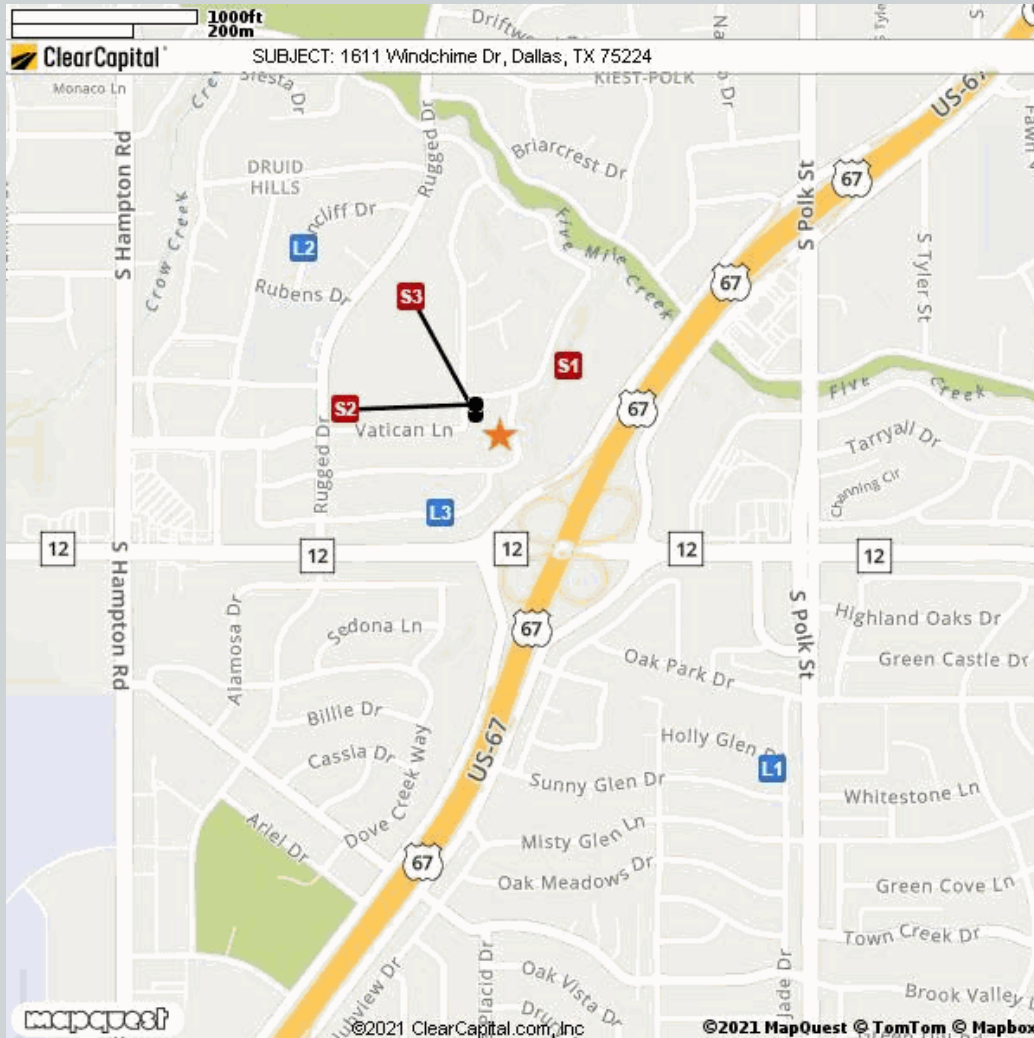
