Reasons for Adjustments Why the comparable sale is superior or inferior to the subject.

- Sold 1** It is inferior because of having a smaller GLA and for having a smaller lot. Overall, similar in design and appeal and has comparable views. Adjustments: \$1740 due to sq ft, \$1081 due to the lot, \$200 due to age, \$3000 due to room count.
- Sold 2** Shows the best support from my value conclusion. Overall, it has the most comparable characteristics and most importantly the most similar location/view which is one of the biggest factors with the subject. Adjustments: -\$4605 due to sq ft, \$1069 due to the lot, -\$200 due to age, \$1500 due to room count.
- Sold 3** It also has the same view as the subject, but its larger GLA, having updates, and having a larger lot makes this superior to the subject. Therefore my value conclusion most aligns with Sale 2. Adjustments: -\$1785 due to sq ft, -\$514 due to the lot, \$800 due to age, \$3000 due to room count, -\$15,000 due to updates.

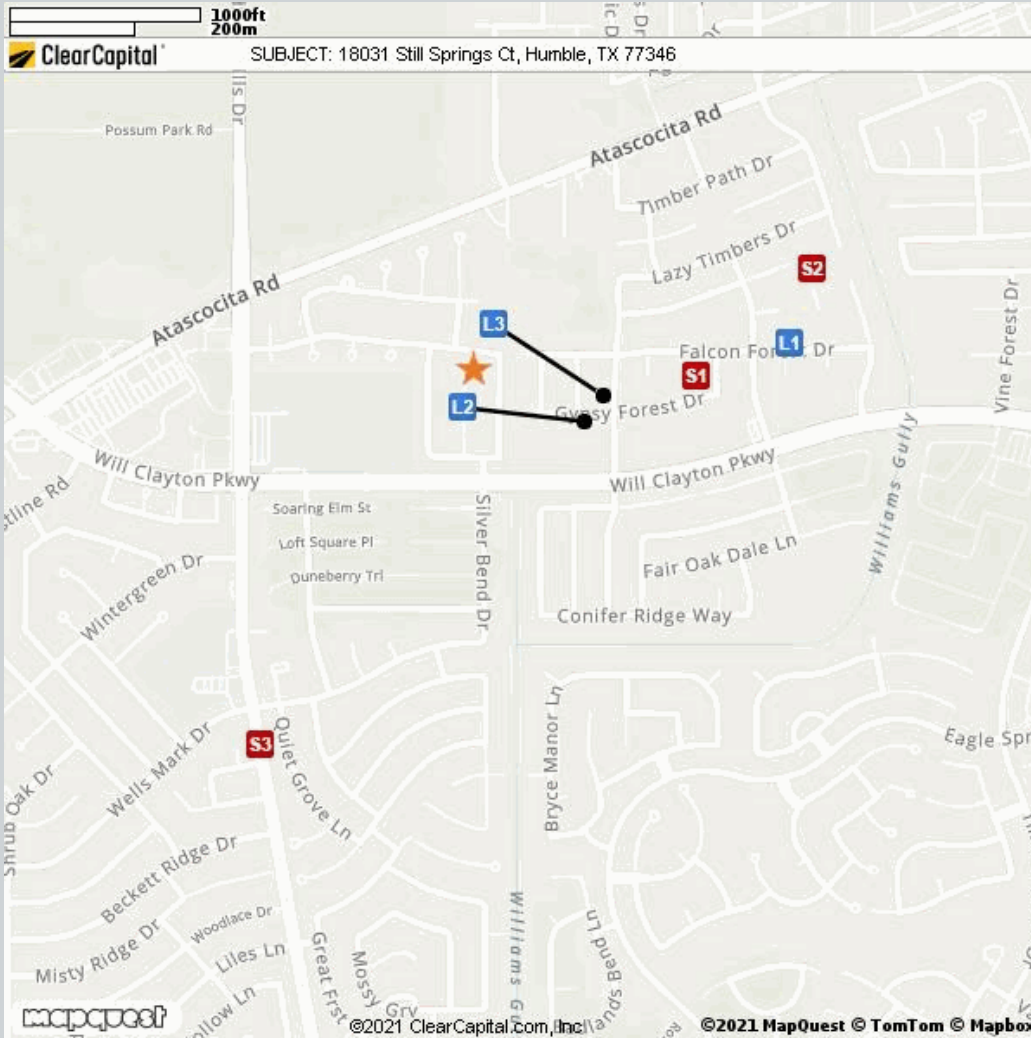
