<p>I went back 3 months, out in distance 0.25 miles, and even with relaxing condition search criteria, I was unable to find any comps which fit the bed bath count requirements. . Due to limited comparables available in the subject neighborhood, it was necessary to use comparables with variance in substyle,lot size , bed count and proximity up to 1.05 miles. Due to limited comps in the area, active comps were used despite not bracketing the bed count as they are still considered to be reliable comparables. The comps used are the best possible currently available comps and the adjustments are sufficient for this area to account for the differences in the subject and comparables. In delivering the final valuation, most weight has been placed on CS1 and LC2, as they are the most similar to subject condition and overall structure. The subject attributes are taken from the Tax record.</p>

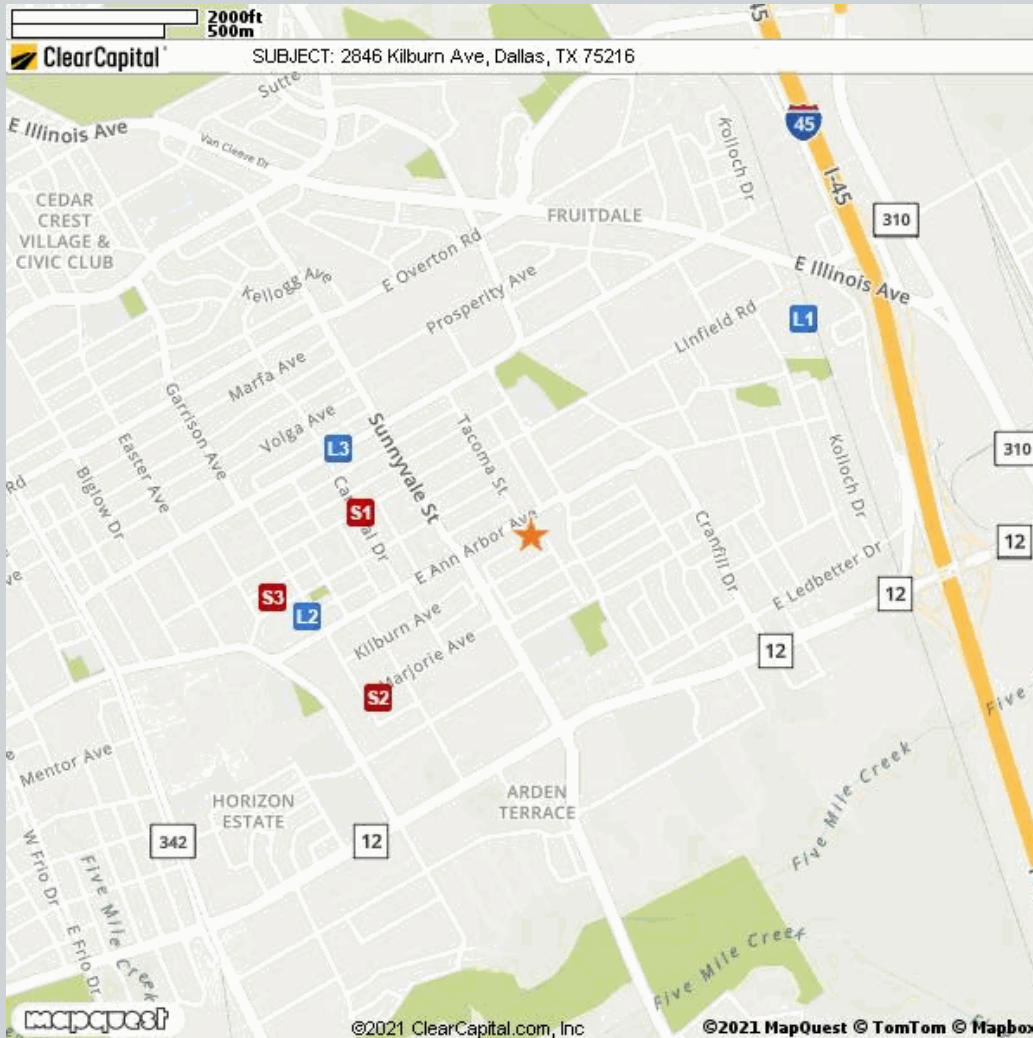
