Sales Comparison Analysis

DESCRIPTION OF COMPARABLE SEARCH CRITERIA

After inspection the subject a thorough search was conducted to find comparables similar to the subject in terms GLA, appeal and overall functionality. Comparable over over 9 moths old were used to to a lack of recent sales in the subjects market area.

EXPLANATION OF ADJUSTMENTS


Lot size adjustment at \$5 per sq ft. over 1,000 sq ft variance Market-based GLA adjustment factor \$70 per sq ft. over 100 sq ft variance. Bedroom adjustment at \$10,000 per bedroom. Bathroom adjustment at \$10,000 per bathroom. Half bathroom adjustment at \$5,000 per bathroom. Car garage adjustment at \$5,000 per single space. Pool/Spa adjustment at \$10,000 for a pool. Comparable 2 was given a negative \$50,000 condition adjustment due to having improved flooring, kitchen, and bathrooms. Cooling adjustment at \$10,000 for having a cooling system installed.

Final estimate of value was reached based on adjusted and unadjusted price of the comparables. Weighted average of the comparables was used to find the final opinion of value. Most weight was given to comparable #1 due similarity and proximity to the subject.
