DESCRIPTION OF COMPARABLE SEARCH CRITERIA

SEARCH PARAMETERS: For our analysis, we have used the following search parameters: Source is CRMLS; Property Type is 'Residential'; Standard Status is one of 'Active', 'Act Under Contract', 'Pending', Standard Status is 'Closed'; Contract Status Change Date is 11/10/2021 to 11/10/2020; Property Sub Type is 'Single Family Residence'; Latitude, Longitude is within 1 mile of 16342 Gentry Ln, City is 'Huntington Beach'; Living Area is 1500 to 2200; Year Built is 1955 to 1975.

EXPLANATION OF ADJUSTMENTS

ADJUSTMENTS: We have inspected the interior of all comps by MLS photos or Realtor comments for the basis of our market grid adjustments. We have made the following adjustments based on a separate paired analysis and our experience in the local market: We have used the factors of \$5 for lot size difference of 1,000 sq ft or more, \$30,000 for condition rating, \$95 for GLA difference, \$10,000 for bedroom count, \$10,000 for bath count, \$5,000 for central air. These adjustments reflect a normal market reaction for these amenities. We have made a separate paired analysis for any actual location adjustments shown on this report from our experience in this market area. Based on paired analysis between the comps in our report, the designs/styles of the comps do not appear to have any impact on their values, hence no design/style adjustments were necessary.

ADDITIONAL COMMENTS (OPTIONAL)

The effective date of this assignment is subsequent to emergency declarations regarding the coronavirus (Covid-19) in March 2020. The scope of this appraisal report does not include the measurement of any effect of these events on the real estate market or on the value of the subject property. Therefore, the value opinion and other conclusions expressed in this report are subject to the extraordinary assumption that these events have had no effect on the marketability or the market value of the subject property. The client and intended users of this appraisal are cautioned that if this extraordinary assumption is incorrect, the value opinion and other conclusions expressed in this report could be significantly different.

Reconciliation Summary

Comp 1 was selected for its similar overall condition and was given primary weight. Comp 2 was selected to bracket he subject's GLA. Comp 3 was selected for its similar bedroom count to the subject. Comps 2 and 3 were given supportive weight. The estimated market value was rounded to \$900,000.

Cost to cure cannot be fully determined by the MLS photos as they were taken as part of the marketing of the subject property and may not completely reflect the condition of the subject or necessary repairs. I have given the subject property C5 condition rating. Any potential cost to cure is reflected in the condition rating. The subject is located in a mostly residential neighborhood with some commercial areas. There appear to be no adverse external influences, the commercial / residential use is typical for the neighborhood. The comps in the report are from the same neighborhood.

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records.
