**Listing 2** Condition seems average and comparable to the subject, overall quality of construction seems average and comparable to the subject. Remains active without reductions, remains within overall area marketing times.

Note 1; quick sale is interpreted to mean all cash sale, it is not known what incentive would be required for a cash sale; for the subject's price bracket 5 % approx is suggested, but is an estimate only, financed offers might be generated within 30 days without any incentive, based on overall market activity.</p>

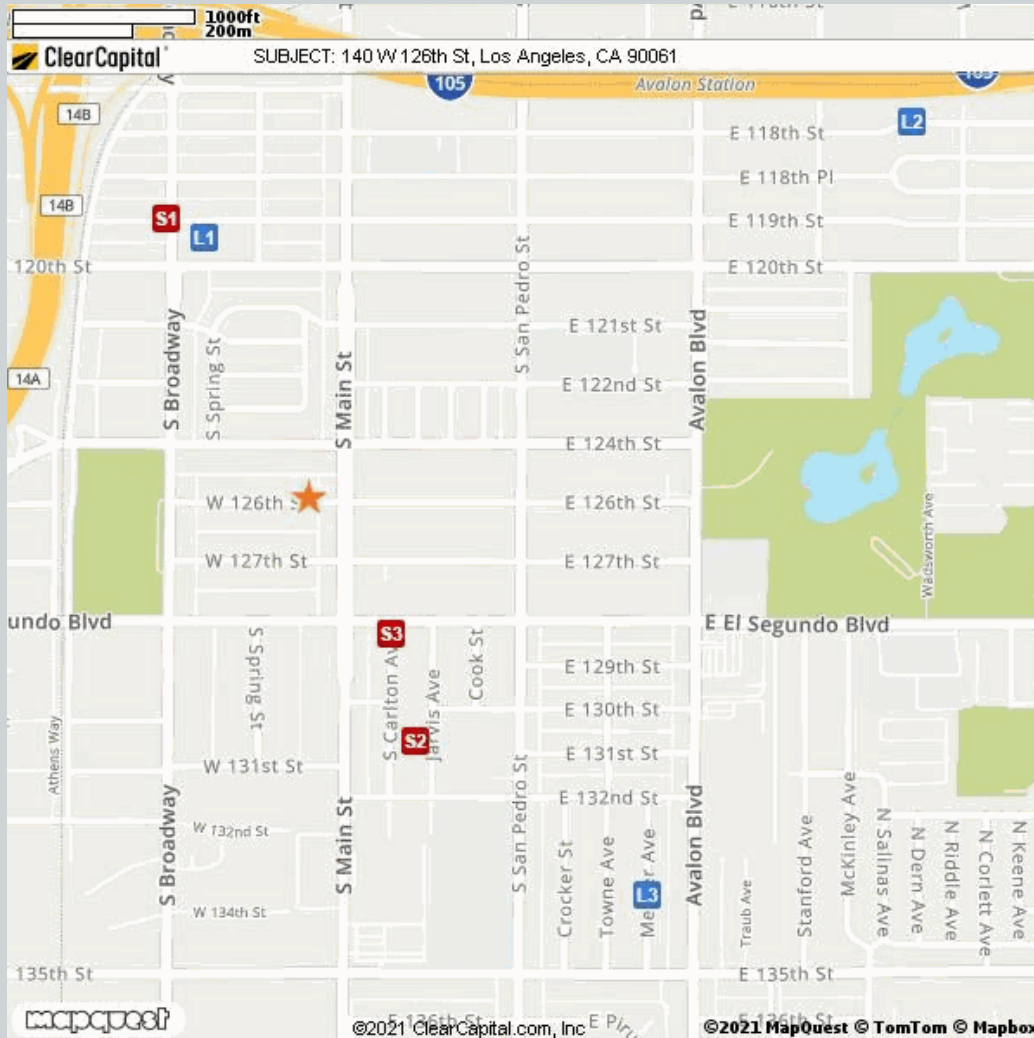
