Therefore it was necessary to exceed the style, bed/bath count, year built, lot size guidelines. In order to use proximate comparable, it was necessary to use comparable having variance in condition. Most of the similar comparable in the subject neighborhood is renovated or having updates, Due to limited availability of similar conditions comparable, I was forced to use compared with some minor upgrades. Subject is located near commercial building, park, school, place of worship and busy main roads. This will not affect the market ability of the subject. Also since there were limited comps in the same side of the subject it was necessary for me to cross highways to get enough comps. This will not affect the market ability of the subject. In delivering final valuation, most weight has been placed on CS2 and LC3 as they are most similar to subject condition and overall structure.</p>

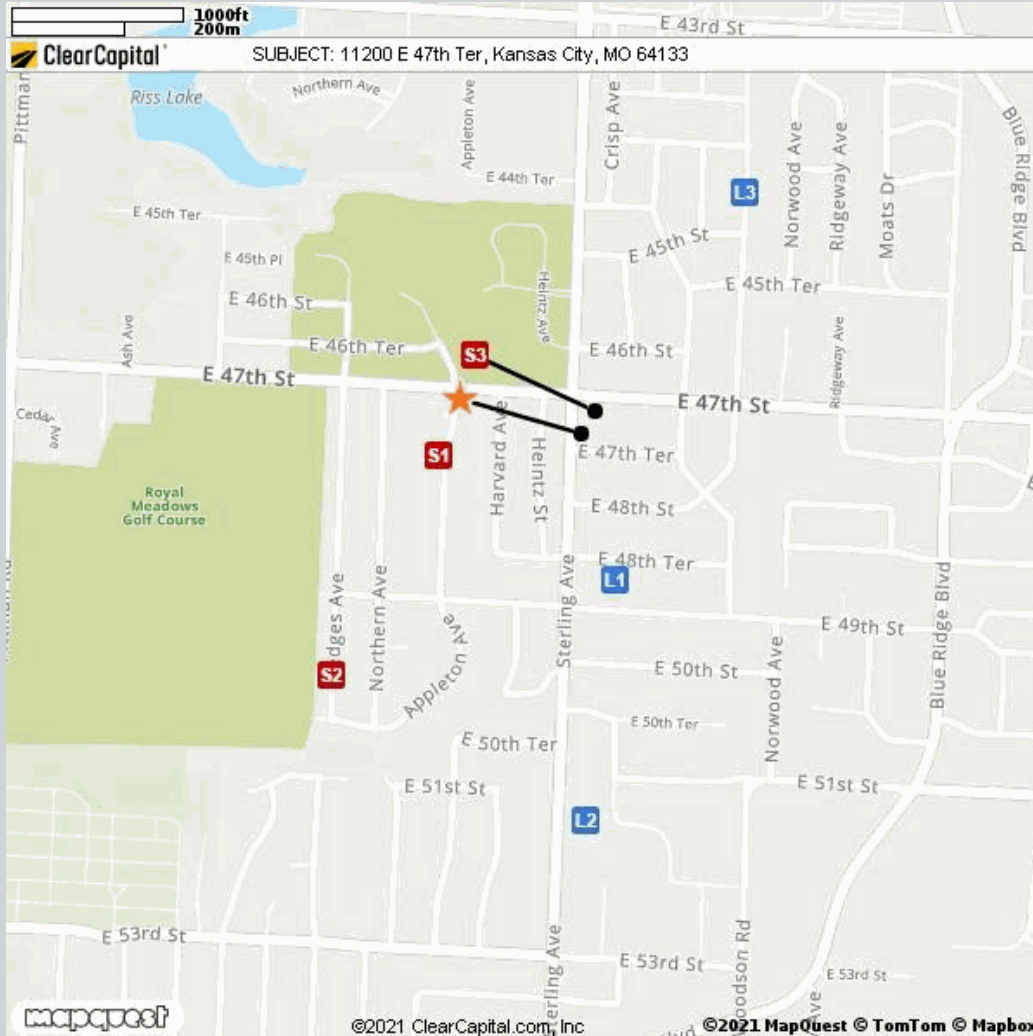
