

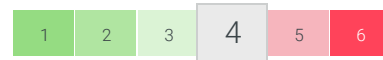

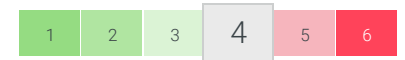

After inspection the subject a thorough search was conducted to find comparables similar to the subject in terms GLA, appeal and overall functionality.

EXPLANATION OF ADJUSTMENTS


Lot size adjustment at \$5 per sq ft. over 1,000 sq ft variance. Market-based GLA adjustment factor \$100 per sq ft. over 100 sq ft variance. Bedroom adjustment at \$10,000 per bedroom. Half Bathroom adjustment at \$5,000 per half bathroom. Garage adjustment at \$5,000 per single space.

This Appraisal Report was performed by a Licensed or Certified Real Estate Appraiser to estimate the market value of the subject property being evaluated as of the effective date of value stated. Clear Capital has provided the appraiser with additional preliminary data resources for consideration in the analysis, which may include: Property Inspection, MLS records, and Public Records.
