Chronological age and site-size differences do not have a significant effect on value. 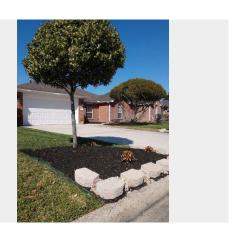

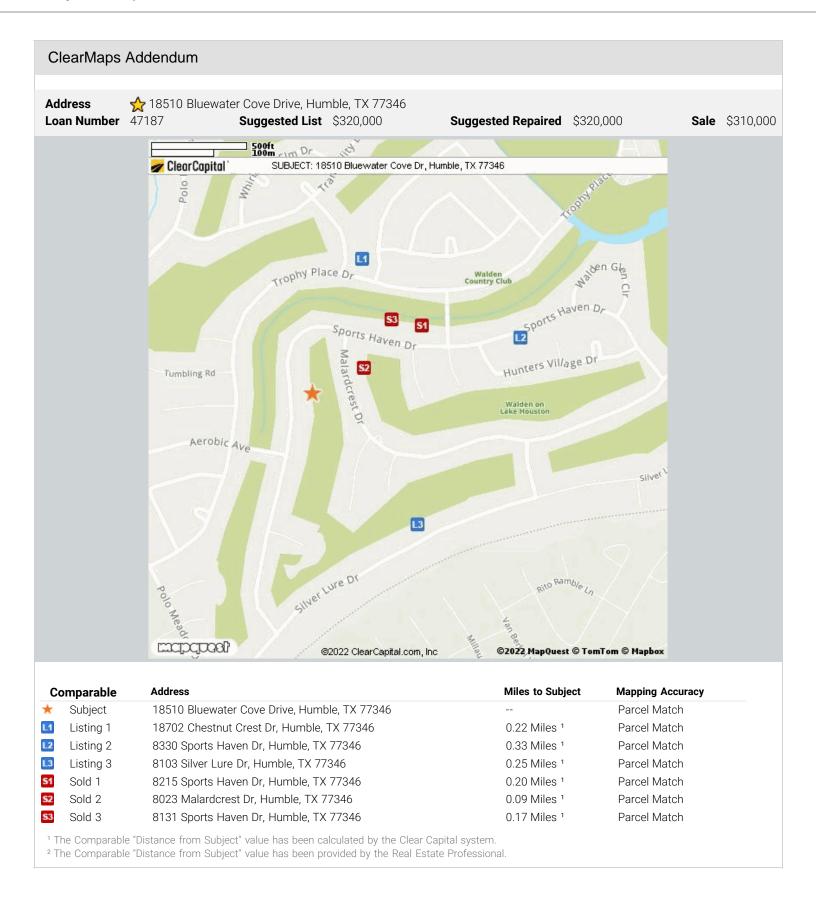
